Lithium Nevada Begins “Bulk Sampling” in What Attorney Calls “A Dirty Trick”

Tribes: “BLM and Lithium Nevada Are Destroying Our Cultural Heritage”



OROVADA, NV —Lithium Nevada Corporation (LNC), the company behind the embattled Thacker Pass lithium mine project, has begun digging up portions of Thacker Pass for “bulk sampling” despite consultation still being ongoing between the Bureau of Land Management and regional tribes over cultural sites.

Will Falk, attorney for the Reno

-Sparks Indian Colony and the Summit Lake Paiute Tribe and co-founder of the opposition group Protect Thacker Pass, says this is a violation of federal law.

“The Federal Government has not even meaningfully started consultation with tribes about the September 12, 1865 massacre site in Thacker Pass, let alone the earlier ‘Peehee

Mu’huh’ massacre [described in oral history](#) and the entire Thacker Pass Traditional Cultural District,” Falk said. “But that doesn’t even begin to describe how much of a dirty trick this is. BLM is allowing the destruction of a massacre site without consulting, over the objections of multiple tribes and members of the public, us-

I would like to update the Community as to issues and projects the Tribal Council and I have been working on during the past month. First of all, we have finally reached a settlement agreement with the State of Nevada Cannabis Compliance Board regarding the opening of the Verdi Tribal Cannabis Dispensary. The agreement finally signed by the Governor, allows the Tribe to open Verdi and to not agree to prohibition of Cannabis Dispensaries on other Tribal properties at this time. The Colony Enterprise Authority (CEA) and Three Nations Management Board (TNM) will have to determine when to open the Verdi Dispensary as we are still not where we want to be financially at the South Virginia St. Dispensary.

As to other issues, we are still monitoring the Thacker Pass Lithium mine project and keeping pressure on the Bureau of Land Management (BLM) on their lack of



consultation with Tribes. Michon Eben and other staff including myself have been speaking at a number of Sate round table discussions on lithium and renewable energy. We will be attending a meeting in Elko Nevada on September 13th to discuss the mining tax issue and give input as to why Tribes should be able to receive tax revenue since the State and Mining Companies have made millions of dollars by greatly impacting the land.


In addition, our Planning Department is working on both our Comprehensive

and Strategic Plans. They sent out a Housing Survey and a General Community Survey which can be filled out on-line, at www.rsic.org, or by completing the paper survey. The information data is very important to plan and allocate Tribal resources in the future and to give us priority needs of the Community both on and off reservation.

The Numaga Pow Wow was a huge success due to the hard work of our Pow Wow Committee, Volunteers and Departments. The Handgame also went well thanks to Winston and the Handgame crew. The recognition to people we lost to Covid was very well received.

Finally, our Covid numbers are still very low which is great news; the Tribe has opened up and lessened some restrictions following CDC protocols.

Who is Eligible?
Households which (1) live on a reservation or live near the reservation and have at least 1 member who is a member of any recognized tribe which (2) meet the income resource eligibility guidelines can participate in the program. Eligibility is based on the income and resources of all members of the household.

How does a household apply for participation?
In order to apply, you must complete the Application Form, provide documentation regarding your household's income and resources, and be interviewed by a certification worker. If you are unable to complete the Application Form, you may obtain assistance from someone who knows you, or the certification worker to help you at the time of the interview.

What information must be presented during the interview?
When you come to your interview, it will be necessary to provide proof of income for all household members. For example, bring your pay stubs, and or award letters for government benefits such as Supplemental Security Income (SSI) or Social Security so the certification worker can determine the total amount income for all household members received during the last 30 days. Statements for all household savings and checking account will also be required. Also information in school tuition grants, loans, and dependent childcare expenses must be verified. Recent utility bills will help verify your address. Having all of these items with you will speed up your household's eligibility determination.

ing a permit more than a decade old.”

“Thacker Pass is a living traditional cultural place where Paiute and Shoshone people still gather to practice our culture,” says Michon Eben, Tribal Historic Preservation Officer for the Reno-Sparks Indian Colony. “The Snake War was the most violent Indian war in the west, and not a single site from this important event for our people is protected. BLM and Lithium Nevada are destroying our cultural heritage with this dig.”

Over the past six weeks, at least four tribes – the Reno-Sparks Indian Colony, Summit Lake Paiute Tribe, Winnemucca Indian Colony, and Pyramid Lake Paiute Tribe – have all demanded that BLM designate the entirety of Thacker Pass as an historic or traditional cultural district eligible for inclusion on the National Register of Historic Places. BLM has also received letters from members of the public and experts such as Alexa Roberts, former National Parks Superintendent at the Sand Creek Massacre Site in Colorado. Ms. Roberts informed BLM of “[striking similarities](#)” between the Sand Creek and Thacker Pass massacres, and urged the agency to protect the entire landscape as a National Historic District.

The tribes assert that all of Thacker Pass should be considered eligible for listing under the National Register of Historic Places because the site con-

tains a unique record of more than 10,000 years of Native American history, including the Thacker Pass component of the “Whitehorse Obsidian Procurement District,” the presence of tools and arrowheads, millennia-old seasonal camps, two massacre sites, oral histories regarding the importance of the Pass, significant [medicinal and food plants](#), culturally-significant animals such as golden eagles and sage-grouse, and ongoing traditions of hunting, gathering, and religious practice.

The tribes are arguing that additional damage to the Thacker Pass landscape jeopardizes its ability to be listed on the National Register of Historic Places.

The Planned Digging

Attorneys for LNC informed mine opponents of the work in a September 9th email, writing that “Lithium Nevada will be performing some bulk sampling under its Kings Valley Lithium Exploration Project Plan of Operations.”

The Kings Valley project was permitted more than a dozen years ago and included only cursory consultation with one tribe. However, BLM has been

[criticized in Federal Court](#) for failing to consider 2009 statements from Dale Barr, then-chairman of the Fort McDermitt Paiute-Shoshone Tribe, made in response to BLM’s inquiries about sacred sites in Thacker Pass and Kings Valley, that Thacker Pass was historically and culturally significant due to oral histories of the “Peehee Mu’huh” massacre.

Despite Barr’s statements being documented in BLM records brought to light in the lawsuit, BLM’s final Environmental Assessment for the King’s Valley Lithium Project states erroneously that “Fort McDermitt Tribal Chairman Dale Barr stated that the Tribe had no concerns about the Project.”

According to oral histories, the Peehee Mu’huh massacre took place on the west side of Thacker Pass, where Lithium Nevada plans to perform their “bulk sampling.” “On July 18th of this year after one year of litigation, BLM finally acknowledges a massacre took place in this area and they still continue to sanction the destruction of our ancestors final resting place, a human rights violation. In simple terms this is cultural genocide being committed on our tribal homelands,” says Eben.

“The scenario that is currently unfolding is precisely why the Reno-Sparks Indian Colony and Summit Lake Paiute Tribe have specifically requested that any construction work or other physical disturbance in Thacker Pass be suspended until BLM

completes the 36 CFR § 800.13 (b)(1) post-review discoveries process,” Falk said. “Yet BLM continues to ignore this request.”



Shelley Harjo, a tribal member from the Fort McDermitt Shoshone Paiute Tribe, has called the planned destruction of Thacker Pass “[the biggest desecration and rape of a known Native American massacre site in our area.](#)”


Max Wilbert, co-founder of Protect Thacker Pass with Falk, recently reported that online bots were being used to [spread online misinformation](#) about protesters. Falk and Wilbert are currently fighting a \$49,890.13 fine levied against them by the BLM after they constructed a pit toilet for native elders as part of a year-long protest encampment last year.

Tribes have recently been made aware of allegations that Native American artifacts were stolen from Thacker Pass during BLM-authorized archeological excavations earlier this summer.

Reno-Sparks Indian Colony Partner with Washoe County Health District on Air Quality Initiative in Hungry Valley and at Reno Colony.

(RENO, NV) The Washoe County Health District – Air Quality Management Division (WCHD - AQMD) partnered with the Reno -Sparks Indian Colony (RSIC) to install two air quality sensors on tribal land and with other community organizations.

The air quality initiative gave people in both Hungry Valley (approximately 800 residents) and the Prosperity Street RSIC locations (approximately 700 residents) the ability to see real-time air quality updates, *which have proven useful recently due to air pollution concerns caused by the nearby Mosquito Fire.*

The collaboration has helped residents specifically in Hungry Valley where there hasn't been air quality sensors before and adds to the number of total sensors in Washoe County in general. Updates from the Purple Air sensors can be seen on online at www.map.purpleair.com which has updated air quality info updated hourly.

RSIC is grateful to WCHD for including their tribal community to help promote better health and prevent sickness due to air pollution.

According to World Health Organizations, outdoor air pollution contributes to millions of deaths every year, making it one of the biggest global health risks. In addition, 9 out of 10 people

worldwide breathe air that exceeds WHO pollution guidelines.

The causes of air pollution vary from human activities (such as coal-fired power plants) to natural events (like wildfires and dust storms).

WCHD-AQMD has distributed more than a dozen Purple Air sensors to community partners that were funded by penalties from air quality violations. Other sensors were given to the Truckee Meadows Parks Foundation, Washoe County Family Engagement Center, Washoe County – Our Place, Washoe County Cares Campus, NV Energy and City of Sparks - Alf Sorensen Community Center.

Air Quality Index	Who Needs to Be Concerned?	What Should I Do?
Good (0-50)	No one. Air quality is good for everyone.	It's a great day to be active outside!
Moderate (51-100)	Some people may be unusually sensitive to particle pollution and may need to take precautions.	Unusually sensitive people: Consider reducing prolonged or heavy exertion. Watch for symptoms such as coughing or shortness of breath. These are signs to take it a little easier. Everyone else: It's a good day to be active outside!
Unhealthy for Sensitive Groups (101-150)	Sensitive groups include people with heart or lung disease, older adults, children and teenagers.	Sensitive groups: Reduce prolonged or heavy exertion. It's OK to be active outside, but take more breaks and do less intense activities. Watch for symptoms such as coughing or shortness of breath. WAITING FOR THE BUS:

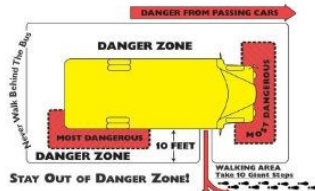
- Be at the bus stop 5 minutes before the bus is scheduled to arrive.

Kids and COVID-19 Vaccines: What Parents and Caregivers Need To Know

Children as young as 6 months of age can get a COVID vaccine.

Both COVID-19 mRNA vaccines are safe for children as young as 6 months of age. Children receive the same vaccine as adults, but the dose is smaller depending on their age.

Children are as likely as adults to be infected with COVID-19 and can spread the virus to others. Children can also get very sick and have short and long-term health complications from COVID.

Both vaccines are effective in reducing the risk of COVID disease and its possible long-term effects. Side effects from the vaccines are usually minor, including fever and soreness where the shot is given.

Contact your local health care provider, clinic or pharmacy to get your child vaccinated.

Ask your child's health care provider about any questions you have about the COVID-19 vaccine.

Reno-Sparks Indian Colony Housing Department (RSICHD) Homeowner Assistance Fund (HAF)

➤ **What is the Homeowner Assistance Fund (HAF)?**

The Homeowner Assistance Fund (HAF) is a federal program to help homeowners impacted by COVID-19 by providing financial assistance for mortgage payments, utility bills and other housing costs to mitigate financial hardship.

➤ **For what purposes can homeowners use HAF?**

- Mortgage Payment Assistance
- Funds to help homeowner reinstate a mortgage or to pay other housing related costs from a period of forbearance, delinquency, or default.
- Principal Reduction
- Interest Rate Reduction
- Utility assistance including gas, electric, water, and internet
- Homeowners' insurance, mortgage insurance
- Homeowners' association fees or liens, condominium fees
- Payment assistance for delinquent property taxes
- Down payment assistance loans provided by nonprofit or government entities

➤ **Who is eligible to receive assistance?**

The RSIC Housing Department (RSICHD) is providing temporary mortgage and home energy assistance to Low-income Native American and Alaska Natives enrolled in a Federally Recognized tribe to mitigate financial hardships associated with the coronavirus pandemic COVID-19 public health emergency. Preference will be given to RSIC members.

➤ **What are the income qualifications or limits?**

Qualified applicants must have income at 150% or below the Area Median Income established the US Dept. of Housing and Urban Development.

➤ **HAF Program Requirements are as Follows:**

1. Attest to experiencing a financial hardship due to COVID-19 after January 21, 2020
2. Describe the nature of the financial hardship (For example, job loss, reduction in income, increased costs due to healthcare, need to care for family member, etc.)
3. Possess income equal of less than 150% of the area median income.
4. Dwelling must be homeowner's primary residence.

To protect life on Earth, we must refuse to extract

We at [Protect Thacker Pass](#) are used to people calling us “delusional”, as David Colborne did in his recent opinion article, [“Refusing to extract lithium is not a refusal to extract”](#) wherein he wrote that “we are every bit as likely as a nation to abandon cars as carbohydrates. Pretending otherwise isn’t environmentalism — it’s delusion.”

Believing we can replace a fossil fuel-intensive energy system with a materials-intensive energy system is the delusion. Yes, abandoning cars, and car-dependent infrastructure, sounds like a fantasy because we’ve weaved cars and fossil fuels into our lives so tightly, we can’t imagine living without them. But lithium, copper, graphite, cobalt, nickel, manganese, iron ore and all the other materials required to build a car with a battery are non-renewable, finite resources, just like oil is. And extracting these materials, and all the others required to build and maintain car-dependent infrastructure, is devastating to the environment just like extracting fossil fuels is. Calling electric vehicles a “solution”, as David Colborne did, is the delusion.

In just a handful of generations, we’ve shifted from everyone on Earth walking everywhere, to everyone in the U.S. (and many others around the world) being unable to imagine life without a car. Colborne rightly pointed out

that we’ve spent the past century building car-dependent infrastructure, and that abandoning this infrastructure is unthinkable to most. But if we fail to recognize this as a huge mistake, and take the option to abandon cars and car-dependent infrastructure off the table, we doom ourselves to repeat the same mistake all over again.

We don’t pretend that people will be willing to give up their cars as long as we live in a culture that requires most people to have a car. All the same, arguments about cars can be made about buses, trains, and planes (all requiring massive amounts of non-renewable materials and infrastructure that damages or destroys the natural world). Our argument is that we need to change this culture. Most people recognize that substituting one kind of car for another won’t make much material difference in the big scheme of environmental destruction, but they can’t imagine what life without almost-instantaneous travel would look like. So this culture continues business basically as usual—whether it’s oil, or lithium, or other non-renewable materials to run that business doesn’t really matter—and so remains steadfastly on the path to self-destruction.

We cannot solve the predicament we’re in—which is not climate change, but catastrophic ecological overshoot, of which climate change is just one of many symptoms—by simply tweaking our way of life.

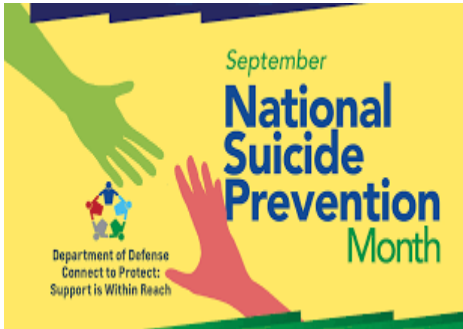
Changing what runs our cars and electrifying the grid doesn’t change the fact that our way of life is fundamentally ecocidal. When every single aspect of our way of life depends on extraction—from the phosphate and ammonia and oil that feeds the world (each calorie of food we eat requires 10 calories of fossil fuels), to the plastic in our clothes, to the steel, concrete, and asphalt that paves the roads and holds up the buildings we drive our cars to every day—changing what powers a car will do basically nothing except continue the same destructive way of life with a slightly different look and feel. We might like to believe driving a different kind of car will make a difference because it’s certainly easier than changing our entire way of life, but believing something doesn’t make it true.

If we as a nation are unlikely to abandon cars and car-dependent infrastructure, then we will find out the hard way a future filled with cars—however, they are powered—is the delusion, one that won’t last for long. True environmentalism is protecting the healthy, flourishing natural world, because nothing else really matters.

National Suicide Awareness Month

INVITATIONS

Invitations are ways someone with thoughts of suicide may be trying to seek help. You may be more familiar with the term “warning signs,” but studies have shown that when people hear “warning signs” they tend to avoid instead of pay attention. Invitations may not always be verbal and can be things that you see the person doing, learn about their life situations, or a feeling that you get from them. Here are a few examples of each:

✦ SEE:

- ⇒ Substance Abuse
- ⇒ Risky Behavior
- ⇒ Negative Social Media Posts
- ⇒ Giving Away Possessions
- ⇒ Extreme Mood Swings

✦ LEARN

- ⇒ Job Loss
- ⇒ Relationship
- ⇒ Financial Trouble
- ⇒ Promotion
- ⇒ New Child

✦ FEEL

- ⇒ Desperation
- ⇒ Hopeless
- ⇒ Grief
- ⇒ Sadness
- ⇒ Defeated

Remember that life situations always come with a loss.

Things that most people may consider a positive may not always be positive for those it is happening to. For those of you have had a child, think about the things that the new parent(s) are losing: sleep, privacy, control of their own schedule, ability to just get up and go, etc. Post-partum depression has a higher prevalence in AI/AN women; 14%-29.7%, compared with all women in the United States; 11% (Heck, J. 2021). Someone with depression is at a higher-risk for having thoughts of suicide.

TELL

Telling someone that you are having thoughts of suicide is important. However, it may be hard for someone to come right out and say that they are having thoughts of suicide, because they are unsure of that person’s reaction. If you find yourself in a situation when you feel that suicide may be involved but the person with thoughts is hesitating, let them know you are listening and want to help. How

do you do that? ASK them.

ASK

Are you talking about suicide? Are you thinking about killing yourself? Are you thinking about ending your life? All of these are direct and will help you determine if you are dealing with suicide or not. These are still hard questions to ask. If you need a little help to get to this question, then start with something like: “I care about you” or “I am worried about you.” If you ask them if they are thinking of hurting themselves, please make sure that you follow that up with a direct ques-



tion about suicide.

LISTEN

Useful information can be gathered by simply listening. Think about the things that you could do to make this experience positive for the person with thoughts of suicide. Judging, interrupting, being distracted, checking your phone, etc. may cause them to shut down. This may be the first

time they are opening up to anyone and letting them to verbalize feelings can be very helpful. Keep in mind, there are those of us who tend to be “fixers” and want to offer suggestions and give advice, but this is not the time for that.

KEEP SAFE

Does the person have a specific plan? Do they have the means (firearms, pills, sharps, etc.)? If so, you can help to dismantle this plan to keep the person safe. Are they willing to involve a family member or close friend to help them stay safe? Are they willing to let you take possession of any firearms and/or ammunition? Are they willing to use a gun lock and give the combo/key to someone else? If they intend to use prescription pills are they willing to give them to someone else? Are they willing to remove the objects they intend to use?

CONNECT

You are not going to solve all of this individual’s problems at once. You can however, connect them with the support they need. The Behavioral Health Department can be reached Monday-Friday 8:00am-5:00pm and by phone at 775-329-5162

As a corporation, TNMC is governed by a board of five voting directors, acting in the best interest of the Authority or “Shareholder” of the Corporation. The Election Board Members shall be compensated at a rate prescribed by the Tribal Council.

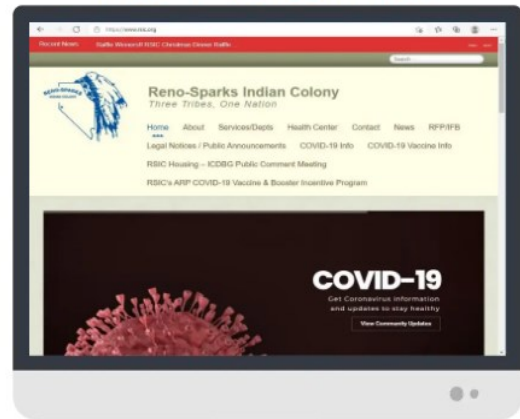
The Standing Rules for Committees and Advisory Boards of the Reno-Sparks Indian Colony were revised and adopted by the Tribal Council on 10-31-2012, Resolution No. 2012-RS-53, Rule No. 8, states – Each person appointed as a member of a committee or advisory board shall not sit on more than two committees or advisory boards at a time; this is combined, meaning that if a person sits on a committee and an advisory board, that person has reached the limit under this rule. The only exception is if a person sits on an intermittent board, such as the Election Board; in that instance the person is subject to the limit of this provision but can sit as a member on one intermittent committee or advisory board. A person can only serve as the Chair of one committee or advisory board at a time, including an intermittent committee or advisory board.

The 2023 Tribal Election will be automated. Training will be provided to the Election Board. The training will include use of the ballots, voting tabulators, voting booths, and the AutoVote Management System. The automated voting process will allow for the 2023 Tribal Election results to be available within 10 minutes after all ballots are cast at the polling sites, at Reno-Sparks Indian Colony and Hungry Valley, and the polling sites are closed.

What is Peer Court?

The Reno-Sparks Indian Colony Peer Court is an alternative court within the criminal justice system for juveniles who commit misdemeanor delinquent acts. Youth offenders are referred to Peer Court by the Tribal Court.

A peer jury made up of middle and high school students hears the youth offender's case. After determining the facts of the case, the peer jury recommends a sentence for the youth offender that is appropriate for the crime and the circumstances.

The youth offender is given an allocated time not to exceed 90 days to complete the sentence handed down by the Peer Court.

Once the consequences have been complied with and the sentence has been completed by the youth offender, the Peer Court will inform the Tribal Court.

Successful completion of the Peer Court requirements will result in the Tribal Court dismissing the charge(s), and no further prosecution or Tribal Court appearances will be required.

PEER COURT MISSION STATEMENT

Our goal as a youth Peer Court is to, decrease juvenile delinquency by promoting positive influences such as peer role modeling, corrective justice and to present opportunities for the youth offender to consider, other than the commission of delinquent acts. Our goal is to foster the implementation of one mind-set "to walk with honor" by abstaining from drugs and alcohol, abiding by all laws, maintaining good school attendance and grades, and by being an overall good citizen.

OUR YOUTH - OUR FUTURE

Why should we have a Peer Court?

The establishment of Peer Courts is going on nationwide. It is a way of dealing effectively with offenses committed by minors, because they are required to face a panel of their peers. The panel is conscious of what penalties have been imposed and can influence other young people, not only to deal with an offense, but also to have a healthier respect for the law. It also gives young people an opportunity to participate in the judicial system so that they can see if they want to study the law or undertake any other law-related profession.

Will the Tribal Court be involved?

The Law and Order Code currently provides that when a young person is accused of an offense, the case may be settled by informal resolution. The Peer Court will be that informal resolution. If the accused does not comply with the decision of the Peer Court, he or she will have to go before the judge in the Tribal Court.

Who will be on the Peer Court Panel?

Five through nine young people who are interested in the court process will be chosen at first. They will serve on several Peer Court hearings. Then anyone who successfully completes his or her penalties will be eligible to be on the Peer Court panel for future cases. Those who have heard several cases will be permitted to serve as advocates for other young people accused of offenses, to argue for lesser penalties or for no penalties at all.

What kind of penalties will be given?

The Peer Court panel will be guided to come up with appropriate penalties that will accomplish two things: (1) to help the youth offender see that his actions have impacted others; and (2) to make things right (corrective justice). For example, if a young person damages property, he or she may be required to apologize to the owner and may have to replace or repair the property.

Parental Involvement:

Parent participation is a must! Parents or legal guardians of the youth offender will be mandated to appear with their child at the Peer Court hearing.

The parents or legal guardians shall be present every step of the way. The parent or guardian shall be the number one disciplinarian to ensure that their child successfully completes the Peer Court sentence.

It has been proven in many cases that positive parent role modeling is the number one key to deal effectively with the youth offender's crisis at hand. Effective parenting techniques ward off future problems.

The Peer Court program is designed for (1) families who are self-motivated and willing to confront the situation at hand, and (2) providing the opportunity to make responsible and positive family choices together.



ANNOUNCING PEER COURT

The Reno-Sparks Indian Colony Tribal Court will begin offering a Peer Court for minors.

What is a Peer Court?

A Peer Court consists of a panel of five to nine young people (under age 18) who will hear the facts of a case and will decide what an appropriate penalty will be for a young person who has violated, certain offenses, the law.

What kinds of penalties will be given?

The Peer Panel will be instructed by the Tribal Court Staff so that they know what their duties are. They will be guided to come up with appropriate penalties that accomplish two things: (1) to help the youth offender see that his actions have an impact on others; and, (2) to make things right. For example, if a young person damages property, he or she may be required to apologize to the owner and may have to replace or repair the property.

Who will be on the Peer Panel?

Five to nine young people who are interested in the court process will be chosen at first. They will serve on several panels. Then, anyone who successfully completes his penalties will be eligible to be on the Peer Panel for other cases. Those who have heard several cases will be permitted to serve as advocates for other young people accused of offenses, to argue for lesser penalties, or, for no penalty at all.
