



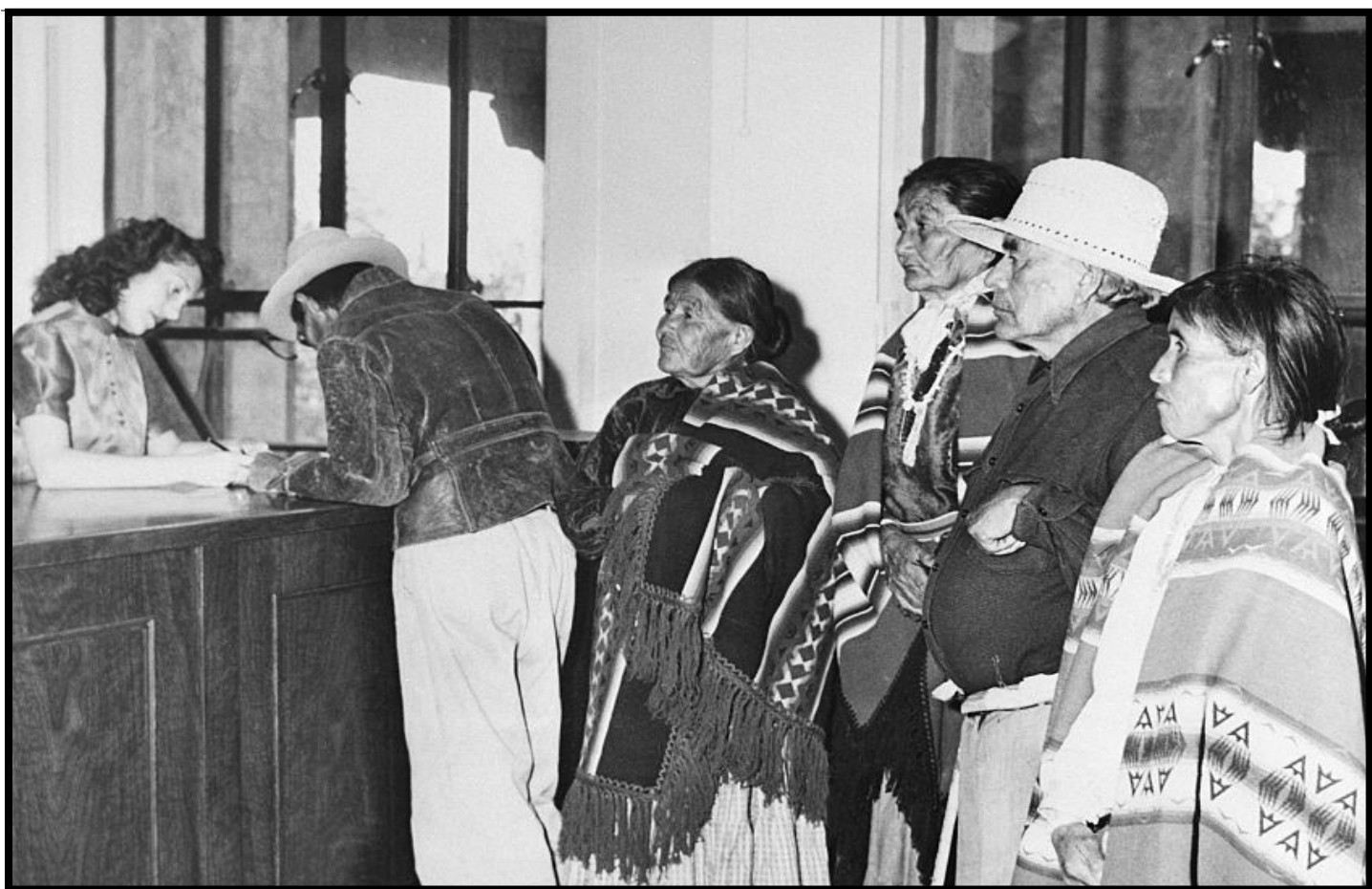

TRIBAL ELECTIONS

Did you know that Native nations' sovereignty allows them to decide for themselves how to govern? The majority of Native nations hold their own regularly-scheduled elections to determine who will create laws and represent their citizens. 574 federally-recognized Native nations, over 60 state-recognized nations, and hundreds of other non-recognized nations share geography with the United States. (The process of seeking federal or state recognition is complex, so we'll save that discussion for another day.) Tribal elections rarely receive mainstream media attention, yet they have important implications for all of us.

Below, we take an introductory look at how Tribal elections work and why they matter.

HOW DO TRIBAL ELECTIONS WORK?

Every Native nation is unique: election processes vary significantly between nations. For the purposes of this discussion, we're going to focus on our organization's service region of Mni Sota Makoce, North Dakota, and South Dakota. Each of the 23 Native nations in this region has a constitution that includes information on elections, such as term limits, candidate eligibility, elected leadership positions, and voter eligibility.

Native nations' constitutions lay the foundation for their governmental processes, structures, and functions. Political term limits vary for Native nations: most have two- or four-year terms. Some Tribal elections take place in the summer, and others take place in the fall at a similar time to elections for non-Tribal governments.

The number of elected positions varies between Native nations, too. In our region, for example, a Native nation's number of elected leaders can range from three to 24. Elected positions have titles such as "Tribal Chair," "Secretary," and "Treasurer," among others.

As for voter eligibility, some nations require that Tribal citizens reside on the reservation to be eligible, whereas other nations allow enrolled citizens living anywhere in the world to vote. The most important takeaway? Native nations and their election processes are extremely diverse.

WHY DO TRIBAL ELECTIONS MATTER?

For Native people, Tribal elections matter because they determine our future. It's important to learn about your nation's elections so you can make your voice heard and play an active role in helping your nation thrive. Your input, contributions, and advocacy matter. Does your nation have a constitution? Constitutions are a great place to start to learn more about how your government and elections work. Your local Tribal College and University (TCU), fellow Tribal citizens (especially elected officials), Tribal historians, and knowledge keepers may also have helpful materials and knowledge related to elections and voting.

For non-Native people, Tribal elections matter because they impact everyone. Native nations make significant contributions to regional and local economies. Did you know they employ more than 700,000 people across the country? In some cases, Tribal governments are outperforming local governments and serve as a model of good governance and innovation. Native nations do not exist in a vacuum; they collaborate and negotiate with local and state governments, along with the federal government, on a regular basis.

Understanding Tribal elections and voting can help non-Native people become better relatives. Having knowledge of how Native nations govern makes it easier to meaningfully advocate for Tribal sovereignty and build relationships with Native people and nations.

Letter of Candidacy

Hello,

My name is Michael Acosta, and I am running for a seat on your tribal council. I am Northern Paiute and have resided on the Reservation for all my life, currently residing on Reservation Rd., and experiencing childhood in Hungry Valley. I am the Son of Adriana Gutierrez, Grandson of Arlan Melendez, and Great Grandson of Don and Sally Melendez. I say these names, because they are the ones who have inspired, and motivated me to invest in myself for the betterment of my community. I hope to expand upon my grandfather's years of service, and sustain the legacy of the Reno-Sparks Indian Colony that our ancestors and elders have paved for us.

I graduated from Robert McQueen High School in 2019, and during this time I was a Founding Member and Treasurer of our local RSIC Unity Chapter. I chose to attend Arizona State University where I earned a Bachelor's Degree in Public Service and Public Policy, with a concentration in Sustainability. Through this program I developed a strong understanding about what it takes to be a public servant, such as how to approach ethical dilemmas, make balanced decisions, and to lead with honesty, integrity, and transparency. I also gained insight on how policy shapes real-world outcomes, and may have unforeseen consequences. I believe it is essential to analyze and research how government policies actually affect communities from multiple perspectives, rather than focusing solely on their stated intentions.

I also minored in Urban and Regional Planning, where I developed my understanding of land and physical space and its relationship to goals such as social justice, economic development, and environmental sustainability.

During my Senior year of college, I gained hands-on experience with grass roots activism, where I advocated for Native American Voting Rights with the Worker's Circle, an organization based in New York, New York.

After graduating, I returned to Reno and began working as a Land Planner with Manhard Consulting. In this role, I gained hands-on experience navigating the laws and regulations of multiple jurisdictions involved in new development projects. I also developed a deeper understanding of the political and economic challenges that often accompany the planning and construction process. In addition, I served as a volunteer member of the RSIC 2040 General Plan Steering Committee, where I worked with the Planning Department to help draft the Comprehensive Plan—a key initiative guiding the future growth and development of Reno-Sparks Indian Colony properties.

Currently, I have recently become employed by the RSIC Human Services department, where I have had the opportunity to assist daily operations, and grasp an understanding of some of the challenges that are prevalent within our community.

If elected to Council, I will advocate for the best interests of our community members and our Tribe, while working to protect and strengthen our Sovereignty. I commend our past Tribal Councils for paving the way and establishing a foundation of governance that will endure for generations. It is now up to us—the next generation—to honor that legacy by protecting what has been built, while continuing to innovate and advance our government for the future.



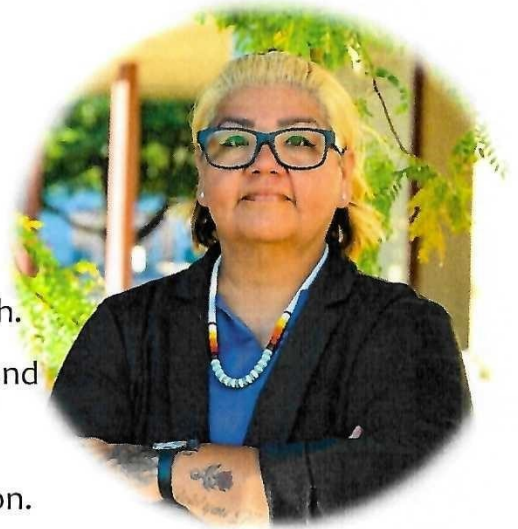

My grandfather, the late, Tellivan Eben was the Chairman in 1964-1966, my mother, the late, Carolyn Moore worked for the tribe over 20 years, Smoke Shop and Clinic, and my son, the late, William Astor worked in IT and Procurement, my daughter, Evalyn Darrough worked for the tribe for 10 years in Childcare and Senior Center. - Jobs! Tribal Member Preference in Hiring. The RSIC jobs are supposed to be Native jobs to stabilize our Native family incomes. Jobs are not created for non-Tribal Members. On-the-Job-Training and apprenticeships are important tools for skill building. Economically empower our People!! HR audits for application receipt, communication, and hiring.
- Community Growth. What is the update on Economic Development—what is being developed? RSIC has not developed new partnerships with retail, have not entered into new leases for tax collection, have not given updates on the Dispensary profits or Spanish Spring property development. We need more homes, 22 houses isn't enough. We need to always add new homes for new families. RSIC is growing. Recognize all RSIC MMIW.
- NEIGHBORHOOD STORES: We need convenience/drive-up stores for essentials/snacks. Let's generate Indian-Indian income and financial opportunities!!!

1. The separation of the HV community and the Reno colony needs to be dissolved. We moved to HV, we were assured that we would not be segregated from the main Colony. BUT, for 30 years the distinction of separate communities still exists. For example, Recreation tickets distribution is only in Reno, on a first come first serve basis. The distribution should take into account the time as well as the gas for HV members to get into Reno, it takes time. Distribution should be done at both sites based on population distribution to be fair.
2. Senior Meals. Many comments from Seniors about the lunches being bland and distasteful and the repetitive menus. A survey should be taken and the results should be seriously considered to improve the quality and variety of the meals while still being nutritious.
3. Education Program. Our population is growing! I have 13 grandchildren. Our Education Program needs more office space to hire more staff to adequately serve our students and take advantage of educational opportunities to excel in school. Full financial aid and support services should be provided for all students regardless of college, university, TMCC, Haskell, vocational or technical schools. We love our children and need to provide the best for them.
4. Library. Being the RSIC librarian, I was told that when the Reno Library modular was destroyed, that a new library would be erected, or space made for a Library. This still hasn't happened. 

RSIC Tribal Government Info

The Reno-Sparks Indian Colony is a sovereign nation. Its tribal government includes an elected chairman and an eight-member council which serves as the governing body per the RSIC Constitution.

The constitution gives the Tribal Council the authority and responsibility to raise revenues, incur expenses, enter into contracts, borrow money, administer funds, purchase land, and provide services for the general welfare and benefit of the Colony's tribal and community members.

As a sovereign Indian nation, the RSIC Tribal Council carries the same unique powers and duties as any city council, county commission, or legislative government across the United States.

Regular, monthly meetings are held to discuss and sometimes vote on matters that affect the Colony, its membership, the community, and any aspect of the tribal government.

The RSIC held its last tribal election on November 4, 2023, and the next tribal election will be November 1st, 2025.

Four of the tribal council seats are up for election every two years, for four-year terms. Five council seats including the Chairman position will be up for election in 2027. Staggered terms allow the governing council greater continuity.

The tribal council is organized to include a chairman, vice-chairman, secretary, and treasurer. The chairman shall be elected by the voters, and the vice-chairman, secretary, and treasurer shall be selected by the tribal council from within its own council membership.

The Colony owns unique traditions, history, culture and languages which are essential for the progress of our tribe. The reservation covers about 15,610 acres and is located in central, west Reno, Nev. The tribal enrollment office reports a total membership of 1,373 as of October 2025.

The tribal council strives to maintain positive, constructive relationships and tribal unity. These important elements are the guiding principles for tribal economic development which exists to improve the quality of life for all, even those yet to be born.

The Colony is an equal opportunity provider in accordance with applicable Colony and federal laws.
