The Defendant will be served with the Summons, Petition, Affidavit and any attachments, physically or through certified mailing. The Defendant will then have 20 days to respond if served physically, or 23 days to respond if served by mail. If no response is received within the appropriate time period, a hearing will be set as soon as possible after the 20 day time period. If a response is received before the 20 day time period is up, a hearing will be set once the Court has received the response. The Court will notify the parties of a hearing date with at least 10 days notice to the parties.
