Once the Petition has been filed a Summons will be issued; the documents will then be forwarded to the Process Server for service upon other interested parties. The other party will be served with the Summons, Petition, and any attachments either physically or through certified mailing. The other party will have 20 days to respond if served. If no response is received within the appropriate time period, a hearing will be set as soon as possible after the 20 day time period has passed. If a response is received before the 20 day time period is up, a hearing will be set once the Court has received the response. The Court will notify the parties of a hearing date with at least 5 days notice to the parties.
