



**RESOLUTION OF THE
RENO-SPARKS TRIBAL COUNCIL**

WHEREAS, the Reno-Sparks Tribal Council is organized pursuant to the provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984, 25 U.S.C. 476), as amended, to provide for certain rights of home rule and to be responsible for the general welfare of its membership; and

WHEREAS, the Tribal Council of the Reno-Sparks Indian Colony is empowered under Article VI, Section 1 of the Constitution and Bylaws of the Reno-Sparks Indian Colony, to enact legislation for the purpose of safeguarding and promoting the safety, and general welfare of the members of the Colony;

WHEREAS, the Tribal Chairman, declared a State of Emergency on March 13th, 2020 due to the COVID-19 pandemic; and

WHEREAS, the Reno-Sparks Indian Colony Tribal Council extended the State of Emergency until April 30th, 2020; and

WHEREAS, the Reno-Sparks Indian Colony passed Resolution No. 2020-RS-30 which established a Mandatory Curfew and Stay at Home Order on all RSIC lands which created 2 new temporary laws into the RSIC Law and Order Code; RSIC Section 4-10-110 Mandatory Curfew and RSIC Section 4-10-111 Stay at Home Order, which that resolution and those temporary laws expire on April 30, 2020 unless extended; and

WHEREAS, the Reno-Sparks Indian Colony Tribal Council closed all Reno-Sparks Indian Colony lands to all non-residents during the State of Emergency; and

WHEREAS, the Reno-Sparks Indian Colony passed directives regarding various RSIC Departments pertaining to employment and regulating essential and non-essential employees; and

WHEREAS, as of April 28, 2020, there is still no sign of the COVID-19 pandemic ending and the RSIC Tribal Council desires to extend all protocols aforementioned in this Resolution until May 31, 2020 or until Council determines it is safe to repeal the safety protocols.

NOW, THEREFORE, BE IT RESOLVED, that the Reno-Sparks Tribal Council hereby extends the RSIC State of Emergency until May 31, 2020 or until Tribal Council repeals or extends the State of Emergency at an alternative date; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, the Resolution No. 2020-RS-30 is hereby extended until May 31, 2020; therefore, the 2 temporary laws established by that resolution will both have the full force and effect of law until May 31, 2020 or until Tribal Council repeals or extends Resolution No. 2020-RS-30 at an alternative date; and

NOW THEREFORE, BE IT FURTHER RESOLVED, that all RSIC employment directives regarding COVID-19 are hereby extended until May 31, 2020 with the exception of the RSIC smoke shop directives or until Tribal Council repeals or amends the Directives as needed at an alternative date; and


NOW THEREFORE, BE IT FINALLY RESOLVED, That the Reno-Sparks Indian Colony closure of all RSIC lands to non-residents except for essential services is hereby extended until May 31, 2020 or unless Tribal Council ends or extends the closure at an alternative date.






