



## RESOLUTION OF THE RENO-SPARKS TRIBAL COUNCIL

**WHEREAS**, the Reno-Sparks Tribal Council is organized pursuant to the provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984, 25 U.S.C. 476), as amended, to provide for certain rights of home rule and to be responsible for the general welfare of its membership; and

**WHEREAS**, the Tribal Council of the Reno-Sparks Indian Colony is empowered under Article VI, Section 1 of the Constitution and Bylaws of the Reno-Sparks Indian Colony, to enact legislation for the purpose of safeguarding and promoting the safety, and general welfare of the members of the Colony;

**WHEREAS**, the Tribal Chairman, declared a State of Emergency on March 13<sup>th</sup>, 2020 due to the COVID-19 pandemic; and

**WHEREAS**, the Reno-Sparks Indian Colony Tribal Council extended the State of Emergency until April 30<sup>th</sup>, 2020; and

**WHEREAS**, the Reno-Sparks Indian Colony Tribal Council extended the State of Emergency until May 31<sup>st</sup>, 2020; and

**WHEREAS**, the Reno-Sparks Indian Colony Tribal Council passed Resolution No. 2020-RS-30 which created a Mandatory Curfew and Stay at Home Order on all RSIC lands which created 2 new temporary laws into the RSIC Law and Order Code; RSIC Section 4-10-110 Mandatory Curfew and RSIC Section 4-10-111 Stay at Home Order, which that resolution and those temporary laws expire on May 31<sup>st</sup>, 2020 unless extended; and

**WHEREAS**, the Reno-Sparks Indian Colony Tribal Council closed all Reno-Sparks Indian Colony lands to all non-residents during the State of Emergency; and

**WHEREAS**, the Reno-Sparks Indian Colony passed directives regarding various RSIC Departments pertaining to employment and regulating essential and non-essential employees; and

**WHEREAS**, as of May 29<sup>th</sup>, 2020, there is still no sign of the COVID-19 pandemic ending and the Reno-Sparks Indian Colony Tribal Council desires to extend all protocols aforementioned in this Resolution until June 30<sup>th</sup>, 2020 or until Tribal Council determines it is safe to repeal the safety protocols.

**NOW, THEREFORE, BE IT RESOLVED**, that the Reno-Sparks Tribal Council hereby extends the RSIC State of Emergency until June 30<sup>th</sup>, 2020 or until Tribal Council repeals or extends the State of Emergency at an alternative date; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that Resolution No. 2020-RS-30 is hereby extended until June 30<sup>th</sup>, 2020 and therefore the 2 temporary laws created by that resolution will both have the full force and effect of law until June 30<sup>th</sup>, 2020 or until Tribal Council repeals or extends Resolution No. 2020-RS-30 at an alternative date; and

**NOW THEREFORE, BE IT FURTHER RESOLVED**, that all RSIC employment directives regarding COVID-19 are hereby extended until June 30<sup>th</sup>, 2020 or until Tribal Council repeals, extends or alters the employment directives; and

**NOW THEREFORE, BE IT FINALLY RESOLVED**, that the Reno-Sparks Indian Colony closure of all RSIC lands to non-residents except for essential services is hereby extended until June 30<sup>th</sup>, 2020 or unless Tribal Council ends or extends the closure at an alternative date.


#### CERTIFICATION
