

Governor Joe Lombardo addresses Nevada Tribal Leaders at the UNR Tribal Leaders Summit

(Reno, NV.) - As the Tribal Leaders filled the Basin Street Club at Makay Stadium, you could feel the enthusiasm awaiting Governor Joe Lombardo.

On Tuesday, January 30th, the UNR Tribal Leaders Summit initiated with Governor Lombardo, UNR President Sandoval, 17 tribes to include their Tribal Chairman and Council Members, tribal staff members, tribal organizations, UNR's Student Research Team, Nevada's

Statewide Economic Development Planning Team, Native Workforce Development, the Nevada Governor's Office of Energy; about 75 people were attendance.

The day began with the presenting of the Eagle Staff and Flags by the Pyramid Lake Veteran Warriors Organization. Followed by a morning blessing by respected elder, Reynelda James and the Paiute Flag Song by RSIC Tribal Member, Chel-

sea O'Daye. She captured the room with her beautiful voice.

Daphne Emm-Hooper, UNR's Director of Indigenous Relations, then welcomed all the attendees.

"This is the very first UNR Tribal Leaders Summit. We're honored to host this historical event for our tribal leaders. Today, you'll hear directly from Governor

Lombardo and have an opportunity to learn about UNR's strategy to engage with tribal communities, the Nevada Statewide Economic Development Plan and research teams. It's important to have discussions with industry leaders that embrace tribal viewpoints. With that said, it's my honor to introduce our Nevada State Governor, Joe Lombardo."

It's the very first time Governor Lombardo has met with any Nevada Tribes. He commended the work of the Nevada Indian Commission and University of Nevada who helped facilitate this momentous occasion. He discussed his priorities and accomplishments that were used to set the conversations for the rest of the day. He also stated the tribes will want to see these priorities be successful in tribal communities as well..

Governor Lombardo addressed accomplishments:

The Native American Fee Waiver and providing educational opportunities to talented Native Americans and removing financial barriers. He also teased President Sandoval stating it's for both colleges, to include UNLV.

One time funding to Duck Valley Indian Reservation for Owyhee's new school. It will be a positive impact on the lives and future generation of our kids.

There is an additional, specialized staff member in the Nevada Department of Education. This staff member's focus is on

building bridges with our tribal communities and understanding our unique needs.

Governor Lombardo addressed priorities:

Healthcare—The health and wellness of all Nevadans is a priority. We are currently working with the Nevada Healthcare Exchange to provide health care access and insurances to all tribal communities. We know this work must expand.

Public Safety for Indigenous Communities and Missing and Murdered Indigenous Peoples (MMIP) in collaboration of ABI25. The State created legislation to collaborate with the Feds to collect data of missing and murdered indigenous peoples in Nevada. Governor Lombardo stated he was on a panel that discussed MMIP and is pleased there is also a Federal mandate to collect data for murdered and missing indigenous peoples. Right now, the Nevada State Police has 1 missing persons in their data collection, Mary Thacker who was last seen on the Reno-Sparks Indian Colony. The Feds reported 16 other relatives, but have no information of who. The state needs the Tribes help to ensure missing and murdered indigenous peoples are being reported to Nevada State Police.

Nevada's Public Lands and Green Energy Transition—Governor Lombardo stated he met directly with Secretary of Interior, Deb Haaland in Washington D.C. on crucial matters that pertain to Nevada's public

lands and the Biden Administrations plans on green energy. His focus is on the safety and inclusion of tribal communities. Right now, there are over 70 proposed lithium mines for Nevada, with Reno being the hub of lithium battery production.

A New Nevada Department Established called Native American Affairs—Last Legislative Session, the Nevada Department of Native American Affairs was created.

Governor Lombardo said, "We realized the importance and had to rise to a different level with Native American Affairs within the State. We want to ensure Nevada Tribes have access to all the services the State offers."

Final priority centers around our rural communities and natural resources— "The communities outside of Reno and Las Vegas very often get overlooked. But not while I'm Governor." Governor Lombardo stated. "I've assigned Tim Robb, from our Natural Resources Department, who is committed to advancing our rural communities and managing natural resources. They've been monumental in support of what Nevada is trying to achieve in rural communities. He is an ear to listen to your concerns in rural tribal communities."

Governor Lombardo closed with, "Enough about our accomplishments and priorities. I want to get to know you all today and what is important to your communities."

ers then had the opportunity to speak directly to Governor Lombardo.

Chairman Gardipe thanked Governor Lombardo and UNR for hosting this event. As well as thanked him for issuing the ARPA State Funding to Reno-Sparks Indian Colony.

RSIC accepted \$714,000 for the shovel ready Housing Project in Hungry Valley. And as of right now, only five tribes have been approved the funding. Chairman Gardipe advocated to Governor Lombardo, that if not all tribes apply for the ARPA funding, RSIC would like to see the funds still be allocated to Nevada Tribes. There may be opportunity to get more funding for RSIC's existing projects.

UNR President Sandoval discussed the Native American Fee Waiver and the University's commitment to provide assistance to Tribes. For example, NAGPRA and helping tribes to repatriate ancestors and sacred items. Providing economic development research and studies for Nevada Tribes to enhance their economy and finding businesses opportunities that make sense for each tribal community. This assistance is also historic in the State of Nevada. Tribes are pleased to have help as Economic Development is a priority for all Nevada Tribes.

Travis Numan, a RSIC Tribal Member and UNR PhD. Student at the Reno School of Engineering, proceeded with a

presentation about our ancestors vision of our people, our spirituality with Mother Earth and how modern sciences are now catching up.

He expressed how Mother Earth is like our bodies, how the waters are like our blood. The theory or knowledge of our ancestors is valuable in today's world. He expressed to the leaders, "If we put a tourniquet on our blood flow of our arm, what's below would die. It's the same for our water and mother earth. This is why free water flow is beneficial for our environment."

Moreover, Numan used the Hopi petroglyph called Prophecy Rock (see page 6).

Numan said "It shows the two paths for those people who are not indigenous of the lands. They are called the two hearted. Consider them the leaders of the world, the presidents, governors, etc.. It shows they want to be good people, but at the same time materialism is directing their direction of thought and what their working towards. It shows 2 paths. One of chaos which is the squiggly line; or building a spiritual relationship with Mother Earth and one another to create a balanced future for all humans; the solid line. Which is why we negotiated the treaties the way we did. We were to become brothers and sisters with the non-natives. Right now we have a choice to make decisions with a materialistic mind and create chaos. Or we have the choice to build a spiritual connection and create

balance in the world again."

Conclusion of the UNR Tribal Leaders Summit

Included presentations from NevadaWorks and workforce development opportunities for tribes and tribal members to take advantage of.

Department of Green Energy spoke about grant funding available to tribes for green energy initiatives.

Lastly, Nevada Tribes heard from UNR's Research Team and Economic Development Planning Team on the benefits of lithium mining and production in the State of Nevada. They discussed how it helps our economy, job opportunities for tribal members and how it will help solve the climate crisis.

Despite the benefits presented, Tribes in attendance were a little disappointed they did not mention culture or protection of sacred sites in their presentation.

TeMoak Tribe also mentioned their opposition to lithium mining due to their experience with Nevada's Gold Mining in their homelands. They expressed the contamination of their waters and desecration of their sacred sites.

The professors heard the tribes out and were pleased to hear their criticisms and feedback. These comments will be added to their research.

Overall, the UNR Tribal Leaders Summit was extremely informative and very helpful considering the State's future plans.

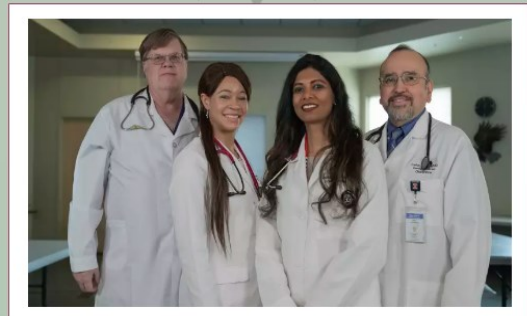

Reno-Sparks Indian Colony Signing Party for Nevada's ARPA Funding



(Reno, NV) - During COVID-19 President Biden signed the \$1.9 trillion American Rescue Plan into law in March of 2021. Under Governor Sisolak's leadership, the State of Nevada received \$2.7 billion dollars for flexible state government aid.

Nevada ended up setting aside \$20 million dollars for the Nevada Tribes called the Governor's Recovery Funds. The Nevada Indian Commission was tasked with creating the application process and is currently the recipient of all applications for approval.

By March 2023, Reno-Sparks Indian Colony (RSIC) was the first tribe in Nevada to apply for these APRA Funds.

Broadly speaking, recipients may use Recovery Funds to:

- ★ **Replace lost public sector revenue**, using this funding to provide government services up to the amount

of revenue loss experienced due to the pandemic

- ★ **Respond to the far-reaching public health and negative economic impacts of the pandemic**, by supporting the health of communities, and helping households, small businesses, impacted industries, nonprofits, and the public sector recover from economic impacts

- ★ **Provide premium pay for essential workers**, offering additional support to those who have and will bear the greatest health risks because of their service in critical sectors

- ★ **Invest in water, sewer, and broadband infrastructure**, making necessary investments to improve access to clean drinking water, to support vital wastewater and stormwater infrastructure, and to expand affordable access to broadband internet

- ★ Deadline for Tribes to Apply is February 29, 2024

RSIC decided to apply for the maximum amount of \$714,000 for the current Hungry Valley Housing Development Project. This funding is being used to supplement the Indian Housing Block Grant (IHBG) of

\$4,430,766.00 to construct 22-manufactured homes with 3-alternative lots.

On January 25, 2024, the Nevada Indian Commission's ARPA Grant Coordinator, Janet Davis, came to RSIC for Chairman Gardipe to sign the final documents to receive the funding.

"Housing continues to be a priority for RSIC. It's our duty to service all 1336 tribal members," Chairman Gardipe said. "COVID-19 showed us how many multi-generational homes are suffering within our community. And how many RSIC Urban Tribal Members are in need of a home on-reservation. This is just the start. I compliment Housing, Fund Development and all departments who helped secure these funds. I also thank State of NV for setting aside these funds for our tribal communities."

Comprehensive Plan Steering Committee is Looking for Volunteers!

Isolate and take precautions if you have or suspect you have COVID-19

ISOLATION



Stay home and away from others
Wear a high-quality mask if you must be around others

Start counting days

Day 0 is the day your symptoms started

If you never had symptoms, day 0 is the day you took a COVID-19 test



911

Watch for emergency warning signs, like trouble breathing
Seek help if they develop

AFTER ISOLATION

Until at least day 11, avoid being around people who are more likely to get very sick
Wear a high-quality mask when around others indoors



Removing your mask

After ending isolation, wear your mask through day 10
OR

Take 2 antigen tests, 48 hours apart

If both tests are negative, you may remove your mask sooner than day 10



ENDING ISOLATION

Isolate to day 6 or later, if you

- never had symptoms or symptoms are improving, and



- are fever-free for 24 hours without the use of fever-reducing medication

Continue to isolate if your fever persists or other symptoms have not improved

Isolate through day 10, if you experienced moderate illness, like shortness of breath or difficulty breathing

Isolate through day 10 and talk with a healthcare provider before you end isolation, if you



- were hospitalized, or
- have a weakened immune system

USDA Ribbon Cutting Ceremony for the Hungry Valley Water and Wastewater System Project



(Reno, NV) - In 2018, Lumos prepared the preliminary engineering report (PER) that resulted in USDA funding the FY19 Hungry Valley Water & Wastewater Project Loan and Grant in the amount of \$2.926 million to provide: water & sewer pipes in the new subdivision; a new water tank & recoat the existing tank; reline the sewer lagoons, and; replace 169 water meters. A separate contract was entered into with Lumos to design the projects identified for the USDA Loan & Grant. Lumos will provide engineering construction services through completion of this 25-Lot Infrastructure project.

The USDA provided \$2.69 million for Hungry Valley Water & Sewer Improvements to include adding a new water tank and relining the existing sewer ponds to increase the infrastructure capacity to provide capabilities for the new housing development identified in the master plan. The 25-lot subdivision infrastructure project is Phase 1 of the master plan. The master plan will incorporate an additional 100-lot infrastructure for full construction of future homesites.

Alex Greenblat and Kristen Tokheim, P.E. have worked as a team to prepare the Hungry Valley Phase 1 Infrastructure Subdivision and Hungry Valley Water and Sewer Improvement engineering plans. The Hungry Valley Water and Sewer Improvement includes the relining of the existing sewer ponds, new water tank, recoat existing water tank and connection of a new water main. On October 11, 2022 for the startup USDA Water and Sewer Project, for the water tank preconstruction meeting occurred laying out preliminary start of construction, staging area for construction, and identifying goals, objectives, and lines of communication for all key players. Contracts for water tanks and sewer ponds are complete and executed. In April 2022, RSIC open bids on sewer ponds. Then June 2022 they open bids for water lines, a new water tank, and re-lining the existing water tank. In July 2022, RSIC Tribal Council approved two (2) construction contracts after USDA concurred with the bid awards.

On December 12, 2023, RSIC and USDA held a Ribbon Cutting for the Hungry Valley Water and Wastewater System Project at the HV Community Room. Public Relations Officer, Bethany Sam, was the moderator for the ribbon cutting. Former Chairman Melendez gave opening remarks and USDA Rural Development State Director, Lucas Ingvaldstad gave further remarks and presented RSIC with certificates. In addition, Senator Rosen's Office, Senator Cortez-Masto's Office, and Congressman Amodei's Office presented RSIC with recognition certificates for the stupendous accomplishment.

Top 10 things your RSTHC-Optometry team wishes you knew:

1. Please bring in your glasses and contact lenses (or past prescription) to your eye exam. If wearing contacts, bring in unopened blister packs.
2. Just because you think you see well or you don't need glasses does not mean your eyes are healthy. Most eye diseases do not have symptoms at first, but in the late stages, can lead to vision loss. It is important to identify and treat eye diseases as early as possible.
3. Vision screenings are not enough. Kids need complete eye exams too. Up to 80% of classroom learning is visual.
4. Eye exams typically take 45 minutes to an hour. Please arrive 15 minutes early to your appointment.
5. Please be prepared to be dilated. This is necessary to fully assess your eye health.
6. Don't keep your health history a secret. High blood pressure, diabetes, thyroid disease, heart disease, etc. can have consequences for your eyes and should be discussed.
7. Also know what medications you are taking, including eye drops. It is helpful to bring your current medication list with you to your appointment.
8. What constitutes a medically necessary walk-in?
 - Red and/or painful eye
 - Bumps on eyelid
 - Trauma
 - Sudden vision loss/change in vision (Please note- longstanding blurry vision "because I lost my glasses" does not count)
 - Flashes/Floaters/Visual disturbances
 - Possible contact lens infection/irritation, etc.
9. Walk-in hours are 8-11 am and 1-3 pm Monday-Friday, except for Wednesday afternoons the clinic is closed. These are on a first come, first serve basis. It is always best to call ahead.
10. Optical has drop in times available for orders, adjustments, repairs, and pick-ups. These hours are daily from 8-11 am and 1-4 pm, but not during Wednesday afternoons.

With January being Cervical Health Awareness Month, I wanted to reach out to you personally to ensure that you are well-informed and empowered to prioritize your cervical health. Our records indicate that you are behind on your cervical exam.

Cervical cancer is largely preventable, and taking proactive steps, such as vaccinations against high-risk types of the human papillomavirus (HPV) and regular screenings like Pap smears, can significantly reduce the risk of developing this treatable condition.

WHY IS CERVICAL HEALTH IMPORTANT?

The cervix is a crucial part of the female reproductive system, and maintaining its health is essential. Cervical cancer, often caused by HPV, is a leading cause of cancer-related deaths in women. However, regular screenings and vaccinations can significantly reduce the risk and catch abnormalities early on.

Why Schedule a Cervical Health Checkup?

Regular checkups are key to preventing and detecting potential issues early. By making an appointment with our medical department, you are taking a proactive step toward safeguarding your cervical health.

SCREENING / EARLY DETECTION

- The U.S. Preventive Services Task Force recommends a tiered screening approach for people with a cervix based on age:
 - For those age 21–29 years, a Pap test every 3 years. A Pap test looks for precancerous or cancer cells on the cervix.
 - For those age 30–65 years, a Pap test every 3 years OR a high-risk HPV test every 5 years OR co-testing with Pap and hrHPV every 5 years.
- In Nevada, about 81% of women ages 21–65 are up to date with cervical cancer screening.

Take charge of your health by scheduling your cervical health checkup today. Your well-being is our priority, and together, we can make a positive impact on the health of our community.

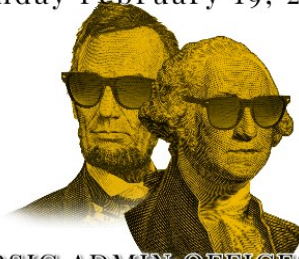

Rosen Introduces Washoe County Public Lands Bill

Washoe County may soon see a boost in development and construction after Nevada's junior U.S. Senator Jacky Rosen announced a new federal land bill on Tuesday.

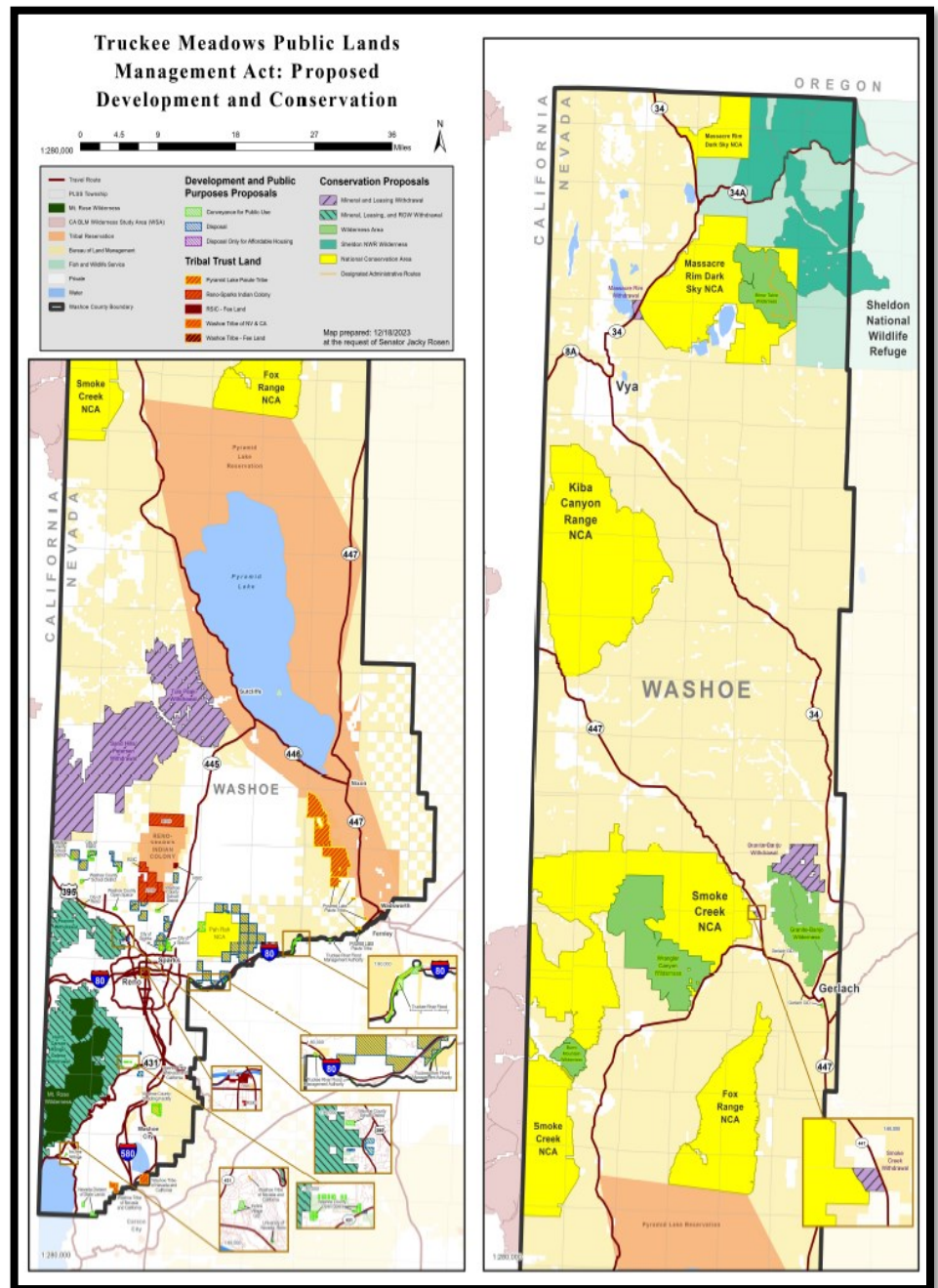
As the state with the highest percentage of public land in the nation, Nevada relies on federal legislation to increase land available for development.

The Truckee Meadows Public Lands Management Act introduced by Rosen would make nearly 16,000 acres of public lands in Washoe County eligible for sale at fair market value to spur economic development, according to [Nevada Current](#).

Washoe County and federal land managers will jointly identify parcels of land suitable for sale. Parcels considered suitable for sale will have to undergo a review by the Bureau of Land Management or the Forest Service before being sold.

Another 3,467 acres of public land will be awarded to local governments in Washoe County for public use, including parks, water treatment facilities, a public shooting range, public schools, and roadway expansions. The University of Nevada, Reno would also be awarded one acre of public land for public use, including a campus expansion, [according to the bill](#).

Under the bill, 30 acres of public land will be reserved for af-



fordable housing. Federal land managers will also need to consider if any of the 16,000 acres of public land for sale is suitable for affordable housing before approving the sale.

“As Washoe County continues to grow, the lack of housing

available can increase home prices at a time when inflation is already hurting Nevada families,” said Senator Rosen in a statement.

The bill would also set aside about 774,000 acres of public land as Wilderness and National

Conservation Areas to prevent further development. Nearly 174,000 acres of public land will also be designated as “withdrawal areas” under the bill, meaning they will be open for recreation, but settlement, sale, or development of the land is prohibited.

Some conservation groups, like the Friends of Nevada Wilderness, praised the bill’s conservation measures, calling it “a milestone in the history of public lands conservation in Nevada.”

“It’s hard to overstate the importance of this legislation for Washoe County and the entire state,” said Shaaron Netherton, executive director of the Friends of Nevada Wilderness. “The conservation, recreation and cultural values of our public

lands are increasingly under stress by climate change and the growing demand for public access to our open spaces.”

If passed by Congress, the bill would also expand more than 21,000 acres of land held in trust for the Reno-Sparks Indian Colony, the Pyramid Lake Paiute Tribe, and the Washoe Tribe of Nevada and California.

Daryl Gardipe, the recently elected chairman of the Reno-Sparks Indian Colony, applauded Rosen and her staff for collaborating with the tribe on the final draft of the bill.

“This has led to the introduction of a lands bill benefitting all parties in an equitable fashion,” Gardipe said. “We are pleased with the support we received from multiple stakeholders to preserve our culturally important areas, while also allow-

ing the surrounding cities to continue their growth.”

Rosen said she has been working on her Truckee Meadows public lands legislation for years with a wide range of affected groups. Earlier this year, Rosen unveiled a working draft of the bill and collected feedback from hundreds of Nevadans during a public comment period, which she incorporated into the current bill draft.

“My bill strikes a balance between responsible development, permanent protection of hundreds of thousands of acres of Nevada’s public lands, and local community growth. I’ll keep working in the Senate to make sure this legislation becomes law, helping to shape a better future for our state,” Rosen said in a statement.

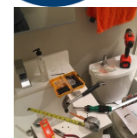

Winter in Nevada is always changing so we must always be prepared for quick changes. Here are a few safety tips that may help during the winter season.

Winter Safety Tips:

Be aware of the winter risks.

Check the local weather forecasts and warnings before heading out. Visit <https://www.weather.gov> for up to date forecasts

- Limit your time outside. If you need to go outside, then wear layers of warm clothing. Watch for signs of frostbite and hypothermia.
- Reduce the risk of a heart

attack by avoiding over exertion when shoveling snow and walking in the snow.

- Avoid carbon monoxide poisoning. Only use generators and grills outdoors and away from windows. Never heat your home with a gas stovetop or oven.

If there is a winter weather advisory please stay off roads if at all possible. If you become trapped in your car, then stay inside.

Winter Driving Tips:

- Avoid using cruise control in wintry conditions
- Steer in the direction of a skid, so when your wheels regain traction, you don't have to

overcorrect to stay in your lane

- Accelerate and decelerate slowly
- Increase following distance to 8 to 10 seconds
- If possible, don't stop when going uphill
- Keep your gas tank full

Make an emergency kit to keep in your car. Include water, snacks, first-aid kit, blankets, flashlight, extra batteries, portable cell phone charger, and emergency flares.

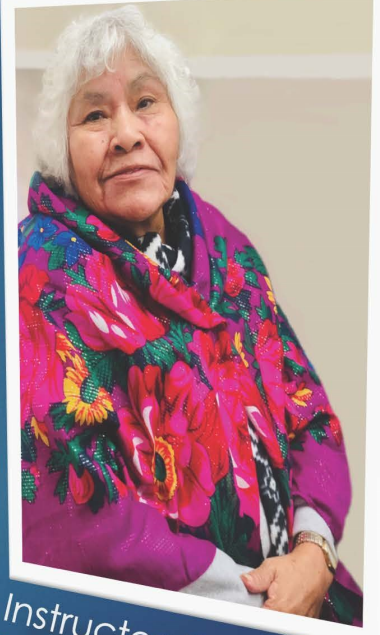

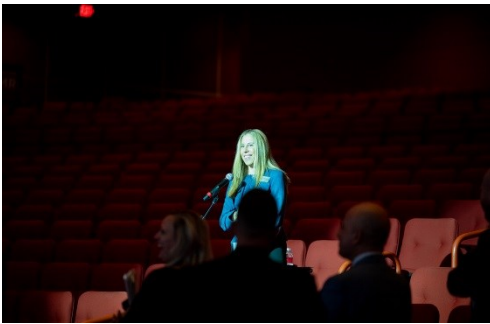

RSIC Tribal Council and RSIC's Powwow Dance Group Participate in a showcase and lunch for the US Dept. of Justice at the Grand Sierra Resort

(Reno, NV) - The Grand Sierra Resort and Casino (GSR) invited the RSIC Tribal Council and RSIC's Powwow Dance Group to participate in a showcase and lunch for the US Dept. of Justice on January 17th at 11am in the Grand Theater.

This showcase at GSR was to help them highlight their partnership and commitment to RSIC for a group of decision makers from the Office for Victims of Crime in Indian Nations Conference ([National Indian Nations Conference | AI/AN Victim Services Resources \(ojp.gov\)](#))).

The Office for Victims of Crime in Indian Nations Conference has been held at the Agua Caliente Casinos on the Agua Caliente Band of Cahuilla Indians for the last 14 years. They are looking to move the conference to Reno, NV.

GSR asked our help to showcase our traditional culture to the decision makers on the Grand Theater Stage (Powwow Group and Eagles Wings do this on a regular basis, perform for conferences and events) and showcase the Tribe's positive relationship with GSR.

Ultimately, they asked us to help them win the bid for this conference and ensure local tribal partnership for the conference, if the Office for Victims of Crime in Indian Nations decides to come to Reno, NV.

First, Chairman Gardipe did a great job doing the welcoming and showing our appreciation to GSR.

"Our neighbor and friends here at the Grand Sierra Resort, agreeably invited us to showcase our culture to you. "Chairman Gardipe stated. "The Reno-Sparks Indian Colony has witnessed the GSR grow and change over the years. To give you some background, this building has been our neighbor since it's been built. We have been working with the Grand Sierra Resort for many years and we have built a very dependable, positive relationship."

Bethany Sam, RSIC's Public Relations Officer, also provided a short presentation about the Reno-Sparks Indian Colony and introduced the Powwow Dance Group.

RSIC Powwow Dance Group performed on the Grand Theater Stage with a grand entrance from the rising stage.

Partial Introduction of RSIC Powwow Dance Group:

"This is in an effort to promote positive cultural identity, and to share the beauty of Indigenous People's practices.

The RSIC Powwow Dance Group's hope is to continue to building bridges through the performing arts.

Our hope is to bring attention to our traditional teachings and old

origin stories and present them in an exciting, old & new, futuristic way. Movement is medicine, movement heals people, and most importantly, culture cures.

We are showing you the movement of our culture, it's a living history. It's not just a performance, it's a responsibility."

The RSIC Powwow Dance Group knocked it out of the park with an amazing performance.

The Dept. of Justice Representative was so impressed, he asked to speak when it was all done to express his amazement and said "when we come to Reno, we want you to perform at the conference."

The GSR Executive team served us an Italian themed lunch and we were able to have a short conversation about opportunities to include RSIC.

Dept. of Justice did state this is the most tribal involvement they've had at any of their conferences. Nothing is set in stone, but the team was definitely impressed.

The OVC oversees grant funding for tribal victim services. RSIC currently has 2 victim services grants with them right now in Human Services.

The 2024 Presidential Preference Primary in Washoe County and Nevada is on Tuesday, February 6, 2024. All registered voters in Washoe County will receive a mail-in ballot (essentially an absentee ballot). Of course, you will need to register to vote if you haven't already done so. Same-day registration is available during early voting and on Election Day.

Same Day Voter Registration with Tribal I.D.

What is same-day registration?

AB 345 of the 2019 legislative session introduced same-day registration to the State of Nevada. Essentially, same-day registration allows a voter to register for the first time or update their existing registration on the same day they vote. While this process is convenient, there are some important details to understand.

If you wish to utilize the same-day registration process you must have a valid Nevada driver's license or ID card and you must vote in-person at a polling location. (Tribal ID cards may also be used if they meet certain requirements - see "Can I use my tribal ID card to same-day register?" below.) Any other form of identification, including a military ID or passport, cannot be used for same-day registration to prove your identity. At the polling location you will present your Nevada driver's license or ID card to the election official and be provided the opportunity to register or update your existing registration. If your Nevada driver's license or ID card does not have your current residential address you will also need to present a valid proof of residence. The following items can be used as proof of residence:

- A military identification card;
- A utility bill, including, without limitation, a bill for electric, gas, oil, water, sewer, septic, telephone, cellular telephone or cable television service;
- A bank or credit union statement;
- A paycheck;
- An income tax return;
- A statement concerning the mortgage, rental or lease of a residence;
- A motor vehicle registration;
- A property tax statement;
- Any other document issued by a governmental agency; or
- A tribal identification card.

A Presidential Preference Primary is a primary election in which a voter indicates a preference for a particular candidate to be a party's nominee for the presidency. Republican and Democrat party members may vote at any of the Presidential Preference Primary polling locations
