## RSIC HOUSING & HUNGRY VALLEY SUBDIVISION IMPROVEMENT PLANS UPDATE

(RENO, NV) - RSIC Housing was able to secure funding to go out to bid for the construction of the Hungry Valley Phase I Subdivision Improvement Plans.

The idea of this project began in 2017, when Lumos & Associates developed the design. Changes since 2018 include construction of a 100,000 gallon

water tank with USDA funds and a HUD grant award of \$4.4 million to install 22-manufactured homes and 3-lots.

The footprint of the Hungry Valley Phase 1 Subdivision is about 15 acres.

Construction costs have been on the rise and RSIC Housing needed more funds to secure

bids.

Tribal Council approved an additional \$2.5 million from the American Rescue Plan Act (ARPA) funding to complete the Hungry Valley Phase I 25-Lot Infrastructure Project. In addition, the 2024 Indian Housing Block Grant added \$29,000 to the existing \$4.4 million grant.

### DEVELOPMENT PLAN

#### OVERALL DEVELOPMENT PLAN

The hungry valley overall development is based on creating 125 home sites separated by meandering roadways, large drainage and open space corridors onsite. An extensive network of trails will be proposed along drainage corridors, providing safe pedestrian connection to / from community center, community parks, and the new outdoor active fields. The following illustrative plan shows the development principles outlined by the vision and goals.

## Office of the Chairman

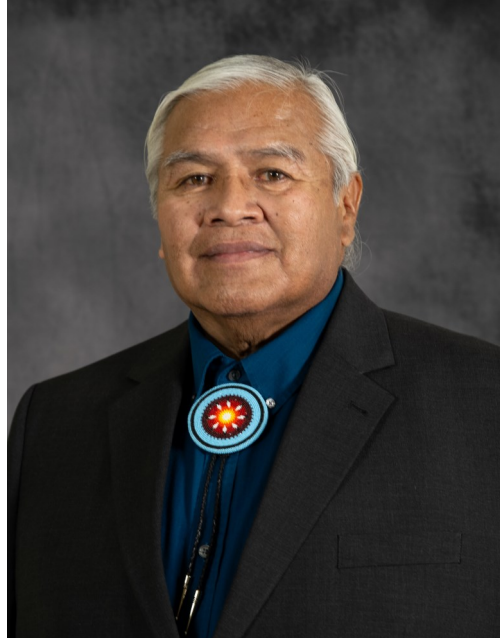
As I've stated monthly, it's a priority to continue to be as transparent as possible. Community input is imperative to the tribe's success. We will be focusing on increasing updates to the community by providing more information and project updates in our Colony Newsletter, RSIC Courier Service on Colony lands, Colony Facebook, website and other social media options. I'm always proud of RSIC and all the work our tribe is doing.

RSIC is flying through the summer. Last week, RSIC's Summer Day Camp teen participants traveled to Southern California to go to Six Flags Magic Mountain, see the ocean, and go to a Dodger's baseball game. One of the teen girls caught a homerun baseball from Shohei Ohtani's (see page 39). And now it's already time to go school shopping. Washoe County begins school on Monday, August 12th. Time has flown by.

Here is my update for the community on what Tribal Council and I have been working on for the month of July:

#### **33rd National Indian Head Start Directors Association Management Conference–**

The last week of June, I attended this conference in Billings, MT. I went to many excellent breakout sessions. The same issues were mentioned all



across Indian Country: over worked and under staffed. Salaries are a big issue. The teachers are required to have a bachelor's degree. Once they accomplish their education requirements, they go to higher paying jobs at school districts or other job opportunities that can offer better employee benefits. One positive change to the Head Start Program was getting rid of the income eligibility requirements for parents to participate. Making it more accessible to tribal member families who want to send their children to RSIC's Head Start.

#### **RSIC Head Start Program**

**Review:** Currently, we are working with the Office of Head Start to rectify the issues that were identified during our Head Start Program Review. We have until September 20th to accomplish this task. The program is in year 5 of a 5-year

grant. We will apply for another 5 year grant this coming month, August.

#### **POLITICS & NETWORK-**

**ING-** I'm continuing to build relationships with our federal, state and local politicians. During the 1st week of July, Brett Scholari, Strategies 360 and I continued meeting with our Northern Nevada Dignitaries. To include, City Councilmen from Reno and Sparks, couple of State Assemblymen, Washoe County Commissioner Clara Andriolo, WC Commissioner Chair Alexis Hill and Reno Mayor, Hillary Schieve.

#### **Cheryl Johnson Retirement**

**Luncheon-** On July 10th, myself, a few RSIC Council Members, and Health Board Members attended a retirement luncheon at the clinic for Cheryl Johnson, RSTHC's Health Administration Office Manager. After 22 years, she said it is time to call it quits and enjoy her family. We all wished her the best and thanked her for all the years of service at RSIC.

**Artown–** RSIC, IGT, Reno Big Arts Little City Arts & Culture Commission, Nevada Arts Council and National Endowment for the Arts sponsored the Cultural Connections entertainment for all of Artown. This included a Pamyua concert at Wingfield Park on July 3rd (Pamyua is a famous indie band from Alaska that showcasing

Inuit culture through music and dance performances) and a reception and art show of Steve Nighthawk's; RSIC Tribal Member; art pieces on July 11th at Sierra Arts Gallery. Many community members were there to show their support. We are thankful to Artown for always including RSIC and our members. I also want to thank our Cultural Resources Program for their assistance to find Native entertainment for the Artown festival.

### **Movie Night at Anderson**

**Park**— The same time as Steve Nighthawk's reception, there was another event happening at Anderson Park. Movie Night & BBQ sponsored by RSIC Human Services, Tribal Police Department and Victims of Crime. We had a ton of community present for this event. I want to thank all the programs who have events for our members and community. It gives the members the opportunity to meet the program staff.

### **Register to Vote for General**

RSIC will be working with our federal and state lobbyist to support political leaders who support Reno-Sparks Indian Colony, Nevada Tribes and Tribes in general.

RSIC has confirmed our polling locations for the presidential election.

- ✦ Early Voting (Oct 19th-Nov 1st) at Reno Multipurpose Room for in-person, ballot drop off and same-day registration.
- ✦ Early Voting (Oct 19th-Nov 1st) at Smoke Shop 6 in Spanish Springs for ballot drop off only.
- ✦ General Election Voting (Nov 5th) at Reno Gym and HV Gym for in-person and same-day registration.

We are also assisting Washoe County recruit tribal members to be poll workers for RSIC's designated polling sites for General Elections. If interested, please contact Bethany Sam, Public Relations Officer at [bsam@rsic.org](mailto:bsam@rsic.org) or 775-842-2902.

### **Healthcare Testimony to Nevada Lawmakers Update:**

Angie Wilson, RSTHC Director and myself both provided presentations to the HHS Joint Interim Committee on Behavioral Health challenges for Tribal Children. The testimony detailed current challenges, historical impacts and recommendations for Tribal Behavioral Health Aides and cultural based practices. Senator Donate, Chairman of the Joint Interim Committee on Health and Human services requested a direct meeting with us to discuss a potential BDR (bill draft request) for the 2025 Legislative session.

Recently, the Senator an-

nounced the Joint Interim Committee would like to support a bill to develop a Nevada Tribal Health Authority, and to include all suggested issues we raised from our infrastructure of this effort. This would be the 1st ever in the State of Nevada.

**Housing:** With the increase of \$29,000 to the Indian Housing Block Grant and additional funding from the Planning Department's BIA Roads fund, plus the ARPA Funds and the savings from the USDA Water & Sewer we can begin the 25-lot Infrastructure project. Once the amendment for final engineering documents are completed to incorporate the sections of Loop Road Improvement Project and preparation of bid documents, the IFB will go out for bid. The public bid is estimated to be posted by end of September 2024 and selection of contractor is estimated for October 2024. Then a timeline of construction will begin. Exciting news for tribal members.

**We have many upcoming events, such as the** Community Picnic & School Supplies / Backpack Giveaway on August 10th at Lazy 5 Park Sunrise Pavilion, Hungry Valley Cleanup on August 9th, RSTHC Health Fair and Blood Drive on August 30th and Numaga Indian Days at RSIC Powwow Grounds from August 30th-September 1st. You will see it advertised locally as we were awarded \$8000 in marketing grant funding. Stay informed by RSIC's newsletter, website and RSIC's social media.

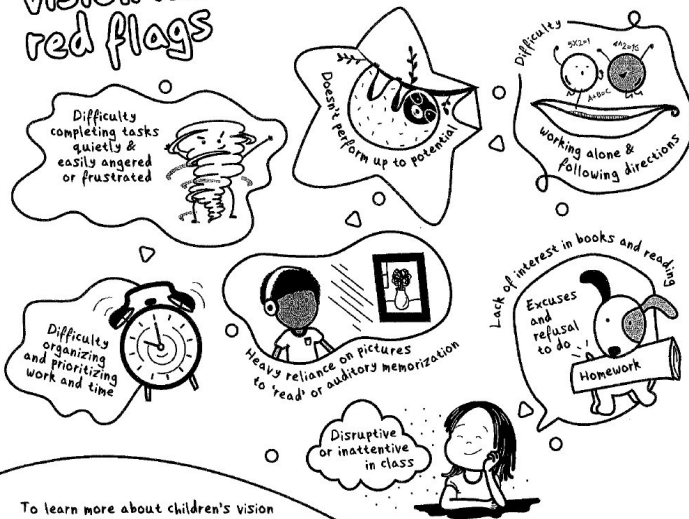

Due to the incorporation of sections of the Loop Road Improvement Project into the 25-lot Subdivision, the Planning Department has partnered with Housing Department to provide \$162,000 of BIA Roads Funds for the completion of the project. The Planning Department will continue to work with BIA to obtain the required permits and final road design requirements.

The Tribal Council has also approved the savings of \$97,000 from the USDA Water & Sewer Capitol Improvement Project (CIP) budget to be utilized for the 25-lot Infrastructure Project.

The combined funds above provide the gap funding needed to begin the 25-lot Subdivision Project in Hungry Valley including the replacement of 164

existing residential water meters for Hungry Valley Homes.

The next step is for the Housing Department to submit an amendment to the engineering contract to the Tribal Council for the incorporation of sections of the Loop Road Improvement Project design into the 25-Lot Subdivision Project design, along with bid preparation.

The amendment will allow for the final engineering documents to be completed with the inclusion of the Loop Road Improvement Project. Once this portion of the design is completed, a public Invitation for Bid (IFB) will be posted for construction project. The public IFB is estimated to be posted towards the end of September 2024. Selection of a contractor is estimated for October 2024. The construction is estimated to take about 6

months from start date.

“We’ve been in a housing shortage for years and during COVID-19 it really showed us how critical it is for RSIC to build homes. Many RSIC homes are overcrowded or our Tribal Members are paying outrageous prices off reservation. Our tribal members deserve the opportunity to choose whether or not to reside on colony lands” Chairman Daryl D. Gardipe stated. “At last, we are ready to begin the construction process. Thank you to all our staff who took part in this project.”

Our advocates offer education on victims' rights and deliver personalized advocacy, empowering individuals to address their needs effectively.*

#### Eligibility:

- An incident of victimization has occurred within the past 90 days
- Victimization occurred within RSIC jurisdictional boundaries
- Open case with law enforcement agency
- Police report on file



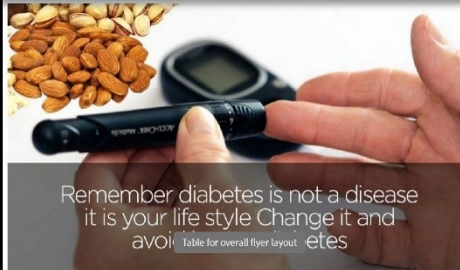

### RENO - SPARKS INDIAN COLONY PRIVILEGE TAX EXEMPTION FORM POLICY

This policy governs the RSIC Tribal Chairman's ability to sign a privilege tax exemption form. It applies to all members of Nevada of the Nevada Indian Tribes residing on lands of the RSIC, in compliance with Nevada law.

In order to qualify for the exemption, the Nevada Department of Motor Vehicles requires the following:

#### Instructions:

- The application for exemption must be submitted for each registration period.
- Separate applications are required for each vehicle. The application for exemption must be presented at the time of registration or renewal.
- A Tribal Chair of a Nevada Indian Tribe must certify that the application meets the eligibility criteria for Governmental Services Tax Exemption.

#### Eligibility:

- The registered owner of the vehicle must be a member of a recognized Nevada Tribe.
- The Vehicle must be located (based) on Nevada Tribal land. The physical address for the vehicle registration must be located on Tribal land within the boundaries of the State of Nevada.

#### Members of the Reno-Sparks Indian Colony

In order to qualify for the exemption, the Reno-Sparks Indian Colony requires the following in addition to the requirements of the Nevada Department of Motor Vehicles.

#### Instructions:

- Tribal member must physically reside on Reno-Sparks Indian Colony or Hungry Valley.
- Tribal member must present a valid state issued identification card or driver's license. The address on the Identification card or driver's license must be a RSIC address.
- Tribal member must present a valid Tribal Identification card, or C.I.B (Certificate of Indian blood)
- The name of the Tribal member requesting the tax exemption must appear on the registration or title of the vehicle.
- Tribal member requesting the tax exemption must sign document in the presence of the RSIC front office staff upon pickup.
- Application must be filled out by a RSIC front office employee
- Once approved by Chairman Tax exemption form will be returned within three business days.
- RSIC front office staff with photocopy documents and will be kept on file for future reference.

#### Required Documentation:

- Tribal Enrollment card or C.I.B
- Valid Driver's License or Nevada Issued Identification Card
- Vehicle Registration or Title of vehicle, DMV Bill of sale with official Nevada seal, Dealers Bill Of Sale.
- Title or Security Agreement from a Financial Institution

#### Members Of Other Nevada Indian Tribes Residing on RSIC

In order to qualify for the exemption, the Reno-Sparks Indian Colony requires the following in addition to the requirements for RSIC Tribal members.

- Must Be a Tribal Member of a federally recognized Tribe in the borders of Nevada.
- Must reside on Reno-Sparks Indian Colony or Hungry Valley.
- Must provide all documents required from a RSIC member.
- RSIC front office staff with photocopy documents and will be kept on file for future reference.

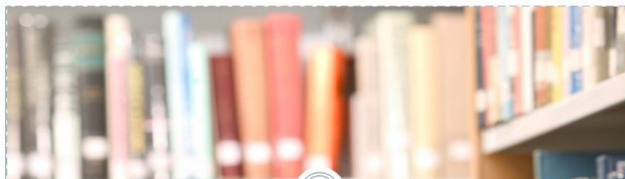

# Safety Tips BEFORE


Morning or Evening Walk



- Check the weather and be prepared for sun, rain or wind
- Drink plenty of water before your walks and avoid alcohol and caffeinated drinks
- Carry extra water with you to drink as you take your walks
- Stick to well-used trails if all possible
- Know the signs of heat sickness and seek shelter if you have symptoms
- Avoid tall grass, weeds, heavy underbrush and crawling in rocks/wood piles where snakes may hide
- If you see a snake do not provoke it, wake it up and do not pick it up, even if it looks dead

Signs of heat sickness include:

- \* Heavy sweating
- \* Weakness
- \* Muscle cramps
- \* Dizziness
- \* Headache
- \* Nausea/vomiting
- \* Fainting

## EXCESSIVE HEAT WARNING

According to the National Weather Service, hot temperatures exceeding 100 degrees are expected through Friday (July 8-12, 2024).

**What to expect:** Dangerously hot conditions with high temperatures

**Impacts:** Extreme heat will significantly increase the potential for heat related illnesses, particularly for those working or participating in any outdoor activities.

**Here are a few precautionary and/or preparedness actions**

- Drink plenty of fluids
- Stay in an air-conditioned room
- Stay out of the sun especially during the hottest periods of the day
- Check up on those relatives and neighbors who are heat vulnerable
- Young children and pets should never be left unattended in vehicles under any circumstance
- Car interior's in hot weather can reach lethal temperatures in a matter of minutes

**Take extra precautions if you do have to work or spend time outside:**

- If possible, reschedule strenuous activities to early morning or evening
- Know the signs and symptoms of heat exhaustion and heat stroke
- Wear lightweight and loose fitted clothing when possible
- If you are outside for extended periods of time take frequent rest breaks in shaded or air conditioned environments
- Anyone overcome by heat should be moved to cool and shaded location. Heat stroke is an emergency so call 911

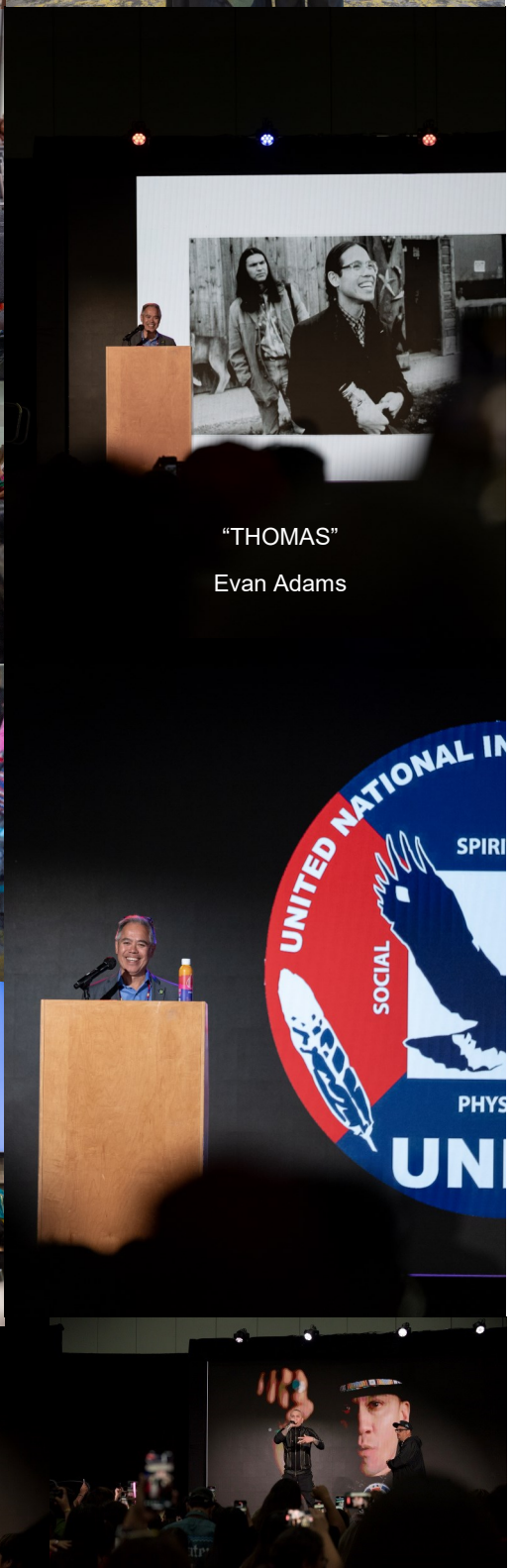
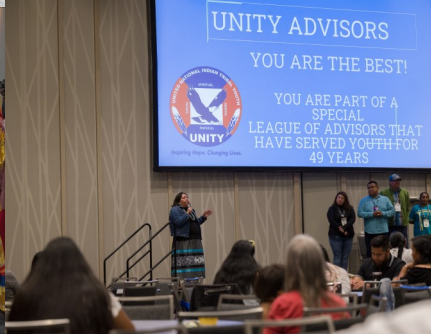

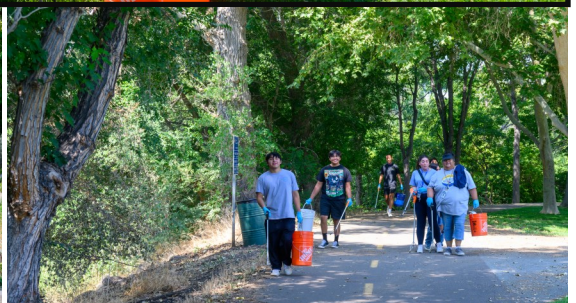

The RSIC Language & Culture team participated in the Nevada State Seal of Bi-Literacy 2 day work session along side fluent speaking elders from various Nevada Tribes. The Seal of Bi-Literacy is an award given by a school or district in recognition of students who have studied and attained proficiency in two or more languages by high school graduation. The Nevada Department of Education would like to offer Great Basin Language advanced placement exams to Nevada students who wish to excel in the Numu, Newe & Wašiw languages and pursue biliteracy.

The elders recorded intermediate level audio passages and written passages in all three Northern Great Basin languages. Fulfilling three of the comprehensive components; listening, speaking and writing. Many of the elders shared stories, songs, and conversations all in their chosen Great Basin Language.

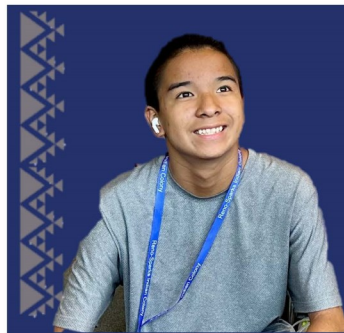
Some of the RSIC language & Culture past and present language teachers were in attendance and ensured they contributed to the assessments for future language students. The RSIC Language & Culture summer youth workers were able to attend in hopes of eventually taking the Seal of Bi-Literacy assessments in the near future. The elders thanked the young learners for being there and introducing themselves in the Numu language. They reminded the elders of the importance of preserving the Great Basin languages for future generations. Many tribes are leading language revitalization efforts in their communities, the advanced placement language exams can be self-initiated and the students do not have to be enrolled in a world language class, as our Great Basin languages are not offered at many high schools in Nevada.

All content was gathered digitally and will be further analyzed by the Nevada Department of Education, World Language Department by the end of the year. In hopes to have the advanced placement assessment available to all Nevada students by next year.





Every year the RSIC Language & Culture program seeks to mentor RSIC youth within the 477 summer youth employment program. Our RSIC Language & Culture 2024 Summer Youth Workers are actively involved with Language & Cultural programming. All three Language & Culture SYEP workers sing and dance our traditional Great Basin songs and dances. Each have committed to learning the Numu language in school, within the RSIC community and at home with family. We are excited to include RSIC youth within our summer language & cultural programming. They will receive hands on experience with developing language lessons, teaching, cultural presentations, cultural crafting and one on one translating with fluent speaking elders. We hope to plant cultural seeds within our SYEP workers and help feed and nurture them as they grow.
