## INDIGENOUS NEVADA VOTERS & POLITICAL POWER:

*Nevada's total tribal population could decide the fate of Nevada's electoral vote*

(Reno, NV) – In just a few days, we will be casting our final votes in 2024 Presidential Election. With Nevada being a battleground state in this election; competitive enough that either Trump or Harris could win by less than 3%; means Nevada's total tribal population could possibly decide the fate of Nevada's electoral vote. Consequently, it's important for Nevada's tribal members to GET OUT THE VOTE.

Nevada has 91,165 Native American Voters, making 3.8% of the voter population of Nevada. Reno-Sparks Indian Colony (RSIC) has about 870 eligible tribal member voters, not including non-members who are residents.

In the 2020 presidential election, Native Americans played a crucial role in Nevada. Voter turnout on tribal lands surged from the 2016 presidential elections and had such a signif-

icant impact it helped Biden win Nevada by 2.39%. Leaders behind the Native Vote mobilization efforts in 2020, stated it was the “largest native voter turnout in Nevada’s history”.

This 2024 presidential election is critical for tribes. The primary issue is to protect tribal sovereignty and uphold the United States to its trust responsibility to tribal nations. Tribes insist inclusion & tribal consultation on all matters; preservation of



# *Office of the Chairman*



November is National Native American Heritage Month where it's a time to celebrate our traditions, languages, and stories, and ensure our history and contributions continue to thrive with each generation. This year's theme is "Celebrating Tribal Sovereignty and Identity".

As Election Day on November 5th approaches, the theme is more important than ever. This Presidential Election we are voting to protect our tribal sovereignty and inclusion. So much is at stake for RSIC in regards to federal funding for healthcare, education, law enforcement, public safety, housing, social services, just to name a few; depending on who wins this election. I can't say it enough, GET OUT THE NATIVE VOTE at RSIC's polling locations or vote online using the Tribal Ease Program.

The holiday season is officially in full swing at RSIC. As we prepare for winter and the holidays, we enjoyed a long month of celebrations and trick or treating. Here is my update for the community on what Tribal Council and I have been working on for the month of October.

**Connie Wyatt Retires after 43 Years of Service to RSIC-** On October 2nd, the Reno-Sparks Tribal Health Center hosted a retirement celebration for Connie Wyatt, after 43 years of service to Reno-Sparks Indian Colony. The conference room was packed with family, friends, co-workers and Tribal Council members. At the luncheon, Angie Wilson, RSTHC Director and the Health Board, gave remarks on how valuable



Connie was to the development of the Health Center and how valuable Connie's positive and helpful attitude made the work environment pleasurable. The Tribal Council and I also did a short presentation and provide her with a much deserved Pendleton blanket. There were many tears and laughter. Thank you Connie Wyatt for serving RSIC for 43 years. You helped to shape a positive atmosphere within our community.

**RSTHC's "Take Your Best Shot" Annual Drive-Thru Flu Vaccine Pod.** On October 9th, RSTHC held the annual "Take Your Best Shot" Flu Vaccine Pod. We gave over 150 flu shots and we actually gained a few more patients to RSTHC.

Hospitalizations from 2009–10 to 2021–22, the age-adjusted hospitalization rate for American Indians and Alaskan Native (AI/AN) adults was 54.6 per 100,000 people, compared to 43.0 for White adults. For children, the rate was 2.5 times higher for AI/AN chil-

dren than for White children. Deaths: Flu and pneumonia are among the top 10 leading causes of death for AI/AN people. The flu vaccine is the best way to protect against the flu and its complications. If you haven't received your flu shot, call RSTHC to schedule today at 775-329-6162.

**POLITICS & NETWORKING-** I'm continuing to build relationships with our federal, state and local politicians. During the month of October I attended many election campaigning events to include the Tim Walz rally at the Grand Sierra Resort on October 8th. At the Tim Walz rally, I was able to meet with him directly for a few minutes with my wife, the first lady, Darlene Gardipe and son Winston Sam. Walz was a down to earth and a kind man. Duane Sherman, Tribal Administrator, Angie Wilson, RSTHC Director, Bethany Sam, Public Relations Officer and Bucky Harjo, Public Relations Assistant were all in attendance from RSIC staff. There many other tribes in attendance as well. It was amazing to see all the indigenous representation at this rally.

On October 9th, we had a private meeting with Senator Jacky Rosen to discuss our current issues; such as law enforcement funding and justice center grant award; and to just catch up. While at our meeting, Senator Rosen presented RSIC with a special recognition for Reno-Sparks Tribal Health Center's National Indian Health Board "Health Warrior Award" and Angie Wilson's "Advocate of the Year Award". I'm thankful Senator Rosen made the time to meet with

us and recognize our accomplishments. Duane Sherman, Tribal Administrator, Mary Lask, Fund Development, Angie Wilson, RSTHC Director, Bethany Sam, Public Relations Officer were all in attendance.

During the Women's March on October 19th, Penny Flanagan, Lieutenant Governor of Minnesota and Ojibwe Tribal Member, walked in the march with us. She was here to campaign for Harris and walk in solitude with our Native women. After the Women's March and in partnership with NV Dems, Duane Sherman, Tribal Administrator, Angie Wilson, RSTHC Director and Bethany Sam, Public Relations Officer attended a private meet and greet at Star Village. Flanagan provided a short campaign speech for Harris and what she will continue to do for our tribal communities. Tribal leaders in attendance also had an opportunity to ask questions.

Yesterday, October 31st, I was able to attend the Harris rally at the Reno Events Center. It was packed and had a large tribal presence.

**Kick Off to Voting and Indigenous People's Day GOTV Events in partnership with Native Organizer Alliance**—On October 12th RSIC hosted a Kick Off to Voting Event in Hungry Valley to promote Native Vote. Indian Country has a big role to play in local, state, and national elections. At this event, we provided dinner and a show by Nā Lei Ho'oheno Aloha: Traditional Dances of Hawai'i. Their beautiful dancing made the evening so special. RSIC UNITY also made stew and frybread for this event.

On October 14th, we hosted an

Indigenous Peoples Day Event at Anderson Park to include special guests, former Chairman Arlan Melendez, Secretary of State (SOS) Cisco Aguilar, SOS Tribal Liaisons, Cal Boone, Walker River Paiute and Sydney Williams, Walker River Paiute. Each speaker talked about the importance of voting and Cal Boone also provided a demonstration on how to do online voting using the EASE Program.

The IDP Event also included stew and frybread made by RSIC UNITY, Round Dance songs by RSIC Tribal Members, and Native Vote swag.

Thank you to Native Organizers Alliance, RSIC UNITY, Public Works, Public Relations, Community Members and special guests for making these events memorable.

**Halloween Events, Senior Fun Day, RSTHC Employee Appreciation Day, Nevada Day Parade**—October was full of costumes, laughter and excitement. I really enjoyed seeing all the Head Start costumes and all the families during the trick or treat nights in both communities.

I enjoyed seeing all our elders in their costumes while visiting and laughing with their relatives at Senior Fun Day.

It was an honor to present our special recognitions from Jackie Rosen and Governor Lombardo at the RSTHC Employee Appreciation Day. Our staff works so hard and has improved the RSTHC experience immensely, they deserved to celebrate with a catered lunch by Famous Dave's. Congratulations RSTHC and thank you for your dedication to our community.

I had to pass this year on the Ne-

vada Day Parade due to conflicting schedules with the NCAI Conference. Thank you staff and Vice-Chairman Anthony Abbie for representing us in the State's biggest parade, Nevada Day.

**VOTE**- I encourage ALL TRIBAL MEMBERS AND RESIDENTS 18+ YEARS to vote!

Vote like our tribal sovereignty depends on it. Because this year, more than ever, it does depend on your tribal vote.

The EASE Program is now available for online voting for tribal citizens who live on a reservation or colony to use this system. The digital voting option is part of an effort to increase voter turnout among the state's Native American communities. To vote online, go to [www.NVEASE.gov](http://www.NVEASE.gov).

lands, language and culture; protection of sacred sites; solutions to MMIP and law enforcement needs; advanced healthcare, including traditional healing; funding for housing & infrastructure; education advancement and truthful tribal history taught in schools; recognition that public lands are native lands; to solve climate change using ancient tribal ecological knowledge; and promote responsible consumerism.

We are building our future together when we use our voices and exercise our rights to vote. The ultimate goal this election is to increase civic engagement by tribal members on reservation and off-reservation.

Civic engagement means working to make a difference in the civic life of our communities and developing the combination of knowledge, skills, values and motivation to make that difference. It means promoting the quality of life in a community, through both political and non-political processes....

A morally and civically responsible individual recognizes himself or herself as a member of a larger social fabric and therefore considers social problems to be at least partly his or her own; such an individual is willing to see the moral and civic dimensions of issues, to make and justify informed moral and civic judgments, and to take action when appropriate.

There are numerous paths for civic engagement:

- Political participation through voting, voter registration, or being an election judge;
- Educating Americans on government and history;
- Volunteering with organizations that build community well-being or participating in community service projects;
- Advocating for legislation and models;
- Representing fellow citizens by appointment or election, such as on a city council or school board.

All of these actions demonstrate how civic engagement is about engaging people in a process of self governance. Values associated with fostering civic engagement are:

- Trusting and respecting how a community wants to take action for itself;
- Creating agency and power in people, particularly those most affected by an issue;
- Nurturing or fostering healthier, stronger, happier places to live;
- Engaging community members in processes that affect them and their communities;
- Promoting transparency and participation


Even though we had a record native turnout in 2020, we still

need to improve voter numbers for 2024. Here are some common reasons for low Native American Voter turnout:

- Geographic isolation, often with lack of reliable transportation and poor access to distant polling and registration locations.
- Non-traditional mailing addresses, overcrowded housing, homelessness, and housing instability.
- Lack of residential mail delivery and limited access to post offices.
- Lack of access to affordable and reliable broadband service.
- Native language translation needs, including non-written, during the voting process.
- Strong socioeconomic challenges, such as poverty and unemployment.
- Historic and ongoing mistrust of state and local governments.

In Nevada, tribal members finally were able to receive voting rights in 1948; 24 years after becoming United States citizens. During these times, non-native voters have been making the decisions for Nevada Tribal Nations on which Politicians are responsible for representing their tribes. It's time all tribal members add input on which Politicians they think will protect tribal sovereignty and look out for the best interest of all tribes.

Nevada Tribes were allowed to have their own polling locations after Pyramid Lake Paiute Tribe and Walker River Paiute tribe filed a lawsuit against Nevada, Washoe County and Mineral County in 2016 for failing to provide adequate early voting and Election Day polling locations on their reservations and won. Since then, over 15 Nevada Tribes, including RSIC, have opted in to have local tribal polling locations for their community while building relationships with their county partners. Both tribal members and non-natives vote at these locations.

With the advocacy of Nevada Tribes and the Nevada Secre-

tary of State, Francisco Aguilar during the 2023 legislature session they passed a state law allowing tribal members living on a reservation to use the online voting system called, Tribal EASE Program. This will help elevate geographic isolation, lack of reliable transportation and poor access to distant polling and registration locations and increase native voter turnout. 

## 2040 RSIC Comprehensive Plan Land Use Element

### Purpose

The purpose of the Land Use Element is to describe the location and type of land uses that exist on the Reno-Sparks Indian Colony and to guide decisions on the location and type of development needed to serve the Colony.

The Land Use Element includes future land use maps as well as goals, policies, and actions to guide Tribal Council decisions on future development.

**Goal 1. Increase involvement in regional and local land use planning to advocate for protection of Colony lands and to protect cultural resources in Washoe County.**

Policy 1.1- Continue to participate and support regional planning initiatives.

Policy 1.2- Continue to monitor and provide feedback to development proposals in adjacent jurisdictions that may create conflicts with the land use element and Colony lands.

Action 1.1- Provide regular updates to Tribal Council on development proposals adjacent to Colony lands.

Action 1.2- Increase involvement in the Truckee Meadows Regional Planning Agency to provide input and collaborate on regional planning efforts, including updates to the Truckee Meadows Regional Plan.

**Goal 2. Increase sovereign land use authority**

Action 2.1- Submit fee to trust or fee to restricted fee applications to the Bureau of Indian Affairs in 2024 consistent with the final rule for CFR 25 Part 151.

**Goal 3. Provide opportunities for new residential, commercial, and community facility land uses to meet the current and future needs of the Reno-Sparks Indian Colony.**

Policy 3.1- Encourage new development that can create negative impacts on air, land, and water quality.

Action 3.1- Develop multi-family & neighborhood commercial uses, such as a small grocery store, adjacent to the Hungry Valley Community Center to provide more services to the Hungry Valley Community.

Action 3.2- Pursue acquisition of the NDOT Surplus land east of Anderson Park.

Action 3.3- Determine new locations for the Public Works Yard and Public Safety Buildings in Hungry Valley to accommodate the build out of the Hungry Valley Subdivision.

Action 3.4- Complete an updated space needs analysis to determine department and program space needs and possible options for new or renovated offices on Colony land.

**Goal 4. Protect Colony lands from illegal uses that pose life and safety hazards.**

Action 4.1- Adopt Building Code Regulations to ensure new construction or new additions on residential properties are compliant with model building codes used by jurisdictions in Northern Nevada.

Action 4.2- Adopt Development Regulations to regulate land uses, signage, height, parking, landscape improvements, setbacks, and density on Colony lands.

**Goal 5. Increase enforcement and coordination of existing ordinances to prevent solid waste on residential properties.**

Policy 5.1- Continue to assist Tribal Police with solid waste enforcement.

Action 5.1- Review possible amendments to Ordinance 46 to augment removal of abandoned vehicles, trash, and debris on residential parcels.

**Goal 6. Increase open space and recreation opportunities along the Truckee River.**

Policy 6.1- Continue to participate and support regional planning efforts, such as One Truckee River, to increase access and improve management of the riverfront areas.

Policy 6.2- Support efforts to implement a Park District in Washoe County, with emphasis on a park district that covers the Truckee River corridor from the CA border to Storey County.

Action 6.1- Complete the design plan for the Truckee River Shared Use Path based on community input and Tribal Council approval.

Action 6.2- Secure funding to begin constructing sections of the Truckee River Shared Use Path.

**Goal 7. Increase protection of open space lands from trespass in Hungry Valley.**

Policy 7.1- Continue to work with BLM, Washoe County Law Enforcement and others to prevent illegal OHV use.

Action 7.1- Implement controlled access in Hungry Valley to decrease trespass occurrences using enhanced way-finding, signage and fencing.

**Goal 8. Ensure new commercial development and community facilities on the Colony reflect tribal culture through artwork, signage, and other motifs.**

Action 8.1- Submit proposed commercial and community facility development projects to the Tri-Basin Cultural Advisory Committee for review and input.

**Goal 9. Ensure capital improvement projects are consistent with the 2040 Comprehensive Plan.**

Policy 9.1- Discourage submittal of capital improvement projects that are inconsistent with the Land Use, Housing, Transportation, and Community Facility Element of the Comprehensive Plan.

Action 9.1- Allow the Planning and Community Development Department to assemble, review, and present CIP projects to Tribal Council as part of the annual budget approval process.

**Goal 10. Improve the decision-making process for residential land assignments and residential land leases.**

Action 10.1- Prepare a new residential land assignment and residential land lease ordinance to remove conflicts with the Probate Ordinance and to provide more clarity on the differences between residential land assignments and residential land leases.

## 2040 RSIC Comprehensive Plan Housing Element

### Purpose

The purpose of the Housing Element is to document current housing conditions on the Reno-Sparks Indian Colony, review housing challenges and opportunities, and provide goals, policies, and actions to address existing and future housing needs.

The Housing Element includes information from the 2022-2023 Housing Conditions Survey and the 2022 Comprehensive Plan Community Survey. Both surveys were carried out by the Planning and Community Development Department.

**Goal 1. Increase the supply of affordable single-family and multi-family housing on the Colony to reduce overcrowding and to allow more members to live on the Colony.**

Action 1.1- Complete the development of Phase 1 of the Hungry Valley Subdivision by 2025.

Action 1.2- Develop new housing on a portion of the Spanish Springs Parcel to provide affordable housing closer to the services located along Pyramid Highway.

Action 1.3- Redevelop the vacant lots along Reservation Road for single-family and multi-family housing.

Action 1.4- Develop a Buy Back Policy to allow vacant homes to be recycled.

**Goal 2. Improve housing conditions for elder homeowners and expand housing choices for elders.**

Action 2.1- Provide accessibility modifications at no cost for elder homeowners on the Colony.

Action 2.2- Prepare an accessory dwelling unit ordinance to allow elders to live with their families in independent dwellings.

Action 2.3- Develop elder housing with supportive services near the Tribal Health Center.

**Goal 3. Preserve and maintain the existing housing stock on the Colony**

Policy 3.1- Support development of a permanent housing rehabilitation program to maintain and upgrade existing owner-occupied housing units on the Colony.

Action 3.2- Implement a free home inspection program for all owner-occupied units to document rehabilitation needs.

**Goal 4. Provide affordable single-family and multi-family housing on the Colony that is not income restricted.**

Action 4.1- Develop policies for development of single-family homes for individual homeowners.

**Goal 5. Increase access to home repair and home construction grant and loan programs to allow Colony members to purchase or construct homes on the Colony.**

Action 5.1- Revise Ordinance 49; Foreclosure and Eviction Ordinance, to provide mortgage lending to Colony members based on approvals from HUD and USDA.

Action 5.2- Submit exception letter to USDA Rural Development for the USDA 502 home loan and USDA 504 home repair grant and loan programs.

Action 5.3- Submit a Memorandum of Understanding to the US Department of Veterans Affairs to enable veteran members of the Colony to apply for VA Native American Direct Loans.

**Goal 6. Develop emergency and transitional housing for community members who are homeless or in need of supportive services due to serious mental health and/or substance abuse disorders.**

Action 6.1- Determine potential locations for emergency and transitional housing in Reno and Hungry Valley and funding needs for such housing.

Action 6.2- Review housing options for the existing Transitional Living Center in Hungry Valley.

**Goal 7. Protect the health and safety of Colony members and the general public**

Action 7.1- Adopt 2018 Building Codes to ensure all buildings are safe, energy efficient, and provide safe access for first responders in the case of emergencies.

Action 7.2- Adopt Visibility standards for new homes to prevent the need for future accessibility retrofits, such as ramps and bathroom renovations.

Action 7.3- Create an emergency housing fund to take care of housing emergencies including water, sewer, and heating emergencies.

## 2040 RSIC Comprehensive Plan Community Facilities

### Purpose

The purpose of the Community Facilities Element is to describe the types of community facilities located on the Reno-Sparks Indian Colony, to assess current conditions along with challenges and opportunities, and to propose goals, policies & actions to address community facility needs.

**Goal 1. Increase educational resources to better serve youth, families, and elders.**

Action 1.1- Implement an Education Campus conceptual plan adjacent to Anderson Park to include a new library and improved parking.

**Goal 2. Create a multi-purpose, year-round facility at the Pow Wow Grounds to better serve Colony members, vendors and visitors.**

Action 2.1- Adopt the Pow Wow Grounds Master Plan during 2024.

Action 2.2- Begin implementation of the recommendations contained in the Pow Wow Grounds Master Plan in 2025.

Action 2.3- Secure grant funding to assist the Colony in implementing the Pow Wow Grounds Master Plan.

**Goal 3. Create a Health and Wellness Campus in Reno to expand health and recreation services for community members who live in the Tribal Health Center service area.**

Action 3.1- Complete the fee to trust process for the new Three Nations Wellness Center parcel located at 1555 Kuenzli in 2024.

Action 3.2- Begin the formal design process for a new Three Nations Wellness Center facility in 2025.

**Goal 4. Improve conditions and amenities at existing parks, trails, and paths on the Colony to increase use of these community facilities by families, youth and elders.**

Action 4.1- Investigate creation of an Adopt a Park program to encourage stewardship of the different park and trail facilities on the Colony.

Action 4.2- Investigate potential locations for community gardens adjacent to community facilities.

Action 4.3- Incorporate signage, seating, and other enhancements at the existing Truckee River Path.

Action 4.4- Develop a formal trail network in Hungry Valley using existing informal trails and OHV routes.

**Goal 5. Increase access to the Truckee River for Colony members and employees who live and work in Reno.**

Action 5.1- Complete the design of the Truckee River Shared-Use Path between John Champion Park and Walmart.

Action 5.2- Secure funding to construct the Truckee River Shared-Use Path.

Action 5.3- Study possible alignments for a southern connection to the Colony Road homes.

**Goal 6. Complete a space needs study for all Colony departments and programs to meet employee and visitor office space, training and storage needs.**

Policy 6.1- Ensure new or expanded facilities needed to address space needs are consistent with the Land Use Element goals, policies, and actions.

Action 6.1- Prepare an analysis of current and future space needs for each department and program.

Action 6.2- Prepare siting locations for a new Public Works yard in Hungry Valley.

Action 6.3- Complete a survey of storage structures on the Colony and prepare recommendations to manage the location and type of storage structures allowed on the Colony.

# Cultural Resources

### Purpose

The purpose of the Cultural Resources Element is to describe the cultural resources and historic preservation protection programs that operate on the Reno-Sparks Indian Colony. This element discusses some of the main challenges and opportunities facing the Reno-Sparks Indian Colony and provides goals, policies, and actions to increase protection and preservation of Native American cultural resources.

### Goal 1. Protect Historic Buildings located on the Reno-Sparks Indian Colony.

Policy 1.1: Provide the necessary resources to maintain and protect buildings that are on the National Register of Historic Places or are eligible for the National or State Register of Historic Places.  
 Policy 1.2: Support the renovation and restoration of the Cultural Resources and Tribal Historic Preservation Office at 1995 E. Second Street located in the Secretary of the Interior's Rehabilitation Standards.  
 Action 1.1: Prepare the final design plans for the renovation of the windows and doors at the Cultural Resources and Tribal Historic Preservation office during 2024.  
 Action 1.2: Complete the renovation of the Cultural Resources Program and Tribal Historic Preservation Office by 2025.  
 Action 1.3: Install a new monument sign with landscaping for the Cultural Resources and Tribal Historic Preservation Office Building.

### Goal 2. Protect and augment the cultural resources inventory of the Reno-Sparks Indian Colony for future generations.

Policy 2.1: Support additional storage and exhibit areas for the Cultural Resources Program and Tribal Historic Preservation Office.  
 Policy 2.2: Support demolition of the structure located at 98 Colony Road and the preparation of design plans for new offices, storage space, and exhibit space for Archives and Records as well as the Cultural Resources Program.  
 Policy 2.3: Improve security to protect cultural items belonging to the Reno-Sparks Indian Colony.  
 Action 2.1: Install security cameras and improved lighting around the Cultural Resources Program and Tribal Historic Preservation Office.

### Goal 3. Prevent land use disturbance and construction activities on the Colony that may threaten culturally sensitive areas.

Policy 3.1: Continue to use the Cultural Resource Monitor for projects involving grading, utilities, or new construction on the Colony.  
 Policy 3.2: Route all building permit applications to the Cultural Resources Program for review.

### Goal 4. Determine potential locations for the Great Basin Native American Cultural Center.

Action 4.1: Evaluate potential locations on Colony parcels in Reno as well as other potential locations in Northern Nevada.  
 Action 4.2: Prepare a conceptual facility master plan once the site has been approved by Tribal Council.  
 Action 4.3: Engage a fundraising consultant and/or solicit grants and loans for the construction of the Cultural Center.

### Goal 5. Increase understanding of the history and culture of the Great Basin Tribes.

Action 5.1: Continue to hold exhibits at the Cultural Resources program and Tribal Historic Preservation building.  
 Policy 5.2: Collaborate with museums and educational institutions in Northern Nevada on future exhibits.  
 Action 5.1: Establish an interpretive signage program along the Truckee River and next to historic buildings on the Colony, including residential structures.  
 Action 5.2: Establish an interpretive signage program for community areas that are open for large gatherings, such as the Pow Wow Grounds in Hungry Valley.

### Goal 6. Protect important cultural areas located on the Reno-Sparks Indian Colony and throughout the aboriginal areas of the three Great Basin Tribes.

Action 6.1: Attend meetings, review and prepare correspondences for federal, state, local, tribal and consulting firms each month for the protection & preservation of Native American cultural resources and Section 106.  
 Action 6.2: Maintain productive & progressive relationships with the RSIC Programs, local tribal agencies and national tribal organizations.

### Goal 7. Increase awareness of cultural resource management and the role of the Cultural Resource monitor.

Policy 7.1: Educate community pertaining to cultural resources and arts and culture.  
 Action 7.1: Facilitate a mobile workshop tour (TBD) for community, members and staff.  
 Action 7.2: Coordinate 1 exhibit (TBD) to be held at the Cultural Resource Program/TIPO.  
 Action 7.3: Plan, coordinate and facilitate the 2024 RSIC Artown event in collaboration with ARTOWN.

### Goal 8. Ensure new development on the Colony carries artwork and symbols of the Three Great Basin Tribes.

Policy 8.1: Continue to involve the Tri-Basin Cultural advisory committee for any proposed residential, commercial, & community facility development projects early in the planning and design process.

# Public Safety Element

### Purpose

The purpose of the Public Safety Element is to describe the existing public safety resources and facilities on the Reno-Sparks Indian Colony as well as the Colony's vulnerability to natural hazards. The Public Safety Element identifies public safety challenges and opportunities and goals, policies, and actions to address many of the identified challenges.

### Goal 1. Reduce risk of damage to Colony land and properties from flooding.

Policy 1.1: Continue to collaborate with FEMA on proposed flood hazard mapping revisions.  
 Action 1.1: Enforce Appendix G of the International Building Code.  
 Action 1.2: Determine if the Colony should participate in the National Flood Insurance Program.

### Goal 2. Improve condition of evacuation routes in Hungry Valley to increase safety of residents and employees.

Action 2.1: Prepare design plans for Chickadee/ West Eagle Canyon to improve condition of the evacuation route.

### Goal 3. Increase safety of residents and first responders for natural and manmade hazards.

Action 3.1: Update interlocal agreements with surrounding public safety agencies and determine if new interlocal agreements are needed to increase safety.  
 Policy 3.1: Continue to participate in the Washoe County Regional Hazard Mitigation Plan five-year updates to leverage resources and improve mitigation resources.

### Goal 4. Increase community safety and resilience from wildland fires.

Action 4.1: Enforce the Wildland Urban Interface Code, adopted as part of the Building Code Ordinance.

### Goal 5. Create a Multi-Purpose Justice Center Campus in Reno to provide integrated public safety and human services for community members.

Action 5.1: Commence the master plan process for the Sunshine Lane parcels in 2024 to include residential and community facility land uses, transportation, location of structures, and open space.  
 Action 5.2: Following the adoption of a Master Plan for the Sunshine Lane parcels, commence the Facility Master Plan for the Multi-Purpose Justice Center at 2 Sunshine Lane to facilitate the relocation of Tribal Court, Tribal Police, and Human Services.

# Conservation Element

### Purpose

The purpose of the Conservation Element is to describe the current conditions of the environment, to understand the challenges and opportunities of the current environmental landscape, and to propose new goals, policies, and actions to honor and protect the land, water and wildlife of the Reno and Sparks Indian Colony for future generations.

### Goal 1. Increase protection from hazardous outdoor air quality events for community members, including elders and young children.

Action 1.1: Revise the Air Quality Index Response Plan to reflect EPA revisions effective May 6, 2024.  
 Action 1.2: Promote awareness and understanding of real-time air quality monitoring sites such as PurpleAir and AirNow.

### Goal 2. Improve indoor air quality for homes, community facilities, and employee offices.

Action 2.1: Restart testing of radon and carbon monoxide in homes and community facilities.

### Goal 3. Develop strategies to reduce greenhouse gas emissions for all types of land uses on the Colony.

Action 3.1: Encourage and participate in local, regional, and state strategies to reduce greenhouse gas emissions.  
 Policy 3.2: Encourage commercial properties to install electric vehicle charging stations for the general public.  
 Action 3.3: Encourage Energy Efficiency retrofits such as insulation, new windows, doors, & appliances by connecting residents with appropriate resources & rebates.  
 Action 3.4: Update the 2011 Comprehensive Energy Audit to determine additional strategies to reduce energy usage on the Colony and to transition away from fossil fuels.  
 Action 3.5: Prepare energy audit analysis for existing solar facilities on the Colony and propose recommendations concerning long-term viability.  
 Action 3.6: Install Electric Vehicle Charging stations at the Tribal Health Center, Hungry Valley Community Center, & other Community Facility locations.  
 Action 3.7: Obtain funding for residential and community solar panels through federal, state, and other resources.  
 Action 3.8: Determine feasibility of utilizing geothermal energy for community facilities on the Colony.

### Goal 4. Reduce and Mitigate Urban Heat Island Effects.

Action 4.1: Develop an Urban Heat Index Response Plan to protect Colony members and employees from excessive heat events.  
 Action 4.2: Ensure existing trees on the Colony are healthy and free of pests.  
 Action 4.3: Survey potential locations for new tree canopy and shade structures on the Reno Colony and the Hungry Valley Community.

### Goal 5. Maintain and enhance ecological datasets about the natural landscape in Hungry Valley.

Action 5.1: Update and enhance Natural Resources GIS databases, including better cataloging of plant species, landscape types, and unique micro-habitats.

### Goal 6. Reduce impacts of Off Highway Vehicle usage in Hungry Valley and restore the landscape.

Action 6.1: Encourage restoration of disturbed landscapes such as burn scars and unauthorized OHV trails where applicable.  
 Policy 6.2: Collaborate with Bureau of Land Management on OHV management of North Reno Recreation area, including Nekadkwe (Moon Rocks).  
 Action 6.3: Implement Hungry Valley Acres Management Plan and Authorized Travel Routes.  
 Action 6.4: Prepare a Rangeland Management Plan to implement the recommendations provided in the 2020 Rangeland Monitoring Report.  
 Action 6.5: Revegetate OHV trails to prevent soil erosion and dust.

### Goal 7. Protect trees and plants by reducing and eliminating invasive plant species on Colony lands.

Action 7.1: Carry out a tree survey to document locations of invasive species and prepare an annual plan to remove invasive trees located on streets, trails, and at community facilities.  
 Action 7.2: Monitor, document, and remove invasive plant species in Reno and Hungry Valley such as cheat grass, thistles, and knapweed located along streets, trails, and at communities facilities.  
 Action 7.3: Prepare educational materials on how to remove or minimize invasive and noxious trees and plants for Colony members.

### Goal 8. Increase use of traditional plants and drought tolerant landscaping on the Colony.

Action 8.1: Promote the use of native plants and pollinators in all areas of the Colony.  
 Action 8.2: Develop landscape guidelines for new residential and commercial development to cover types of trees and plants to be used for residential and commercial land uses.

### Goal 9. Protect water quality and ecosystem health in the Truckee River.

Action 9.1: Continue to support One Truckee River and implementation of the Phase I Truckee River Management Plan.  
 Action 9.2: Establish regular trash removal along the river and install trash and dog waste receptacles along the Truckee River.  
 Action 9.3: Amend Ordinance 10C to address animal waste in public areas of the Colony, including trails and paths.

### Goal 10. Protect and Improve the natural floodway and floodplain of the Truckee River.

Action 10.1: Continue to work with Carson Truckee Water Conservation District to remove diseased and dead trees along the riverbank.  
 Action 10.2: Develop higher standards for proposed development along the Truckee River to protect the natural floodplain.

### Goal 11. Increase protection of existing groundwater resources in Hungry Valley.

Action 11.1: Implement a wellhead protection plan to protect the groundwater in Hungry Valley.  
 Action 11.2: Enhance GIS and natural resources datasets about location and extent of intermittent/ephemeral drainages in areas outside of the original Hungry Valley colony boundaries.  
 Action 11.3: Develop tools to report and remove illegal dumping of tires, construction debris, and other hazardous waste on Colony lands.

### Goal 12. Increase protection of wildlife in all areas of the Colony.

Action 12.1: Protect natural and manmade water features which support wildlife, including natural springs and stockwater wells.  
 Policy 12.2: Ensure development does not interfere with wildlife migration corridors.  
 Action 12.7: Require analysis of potential wildlife impacts for proposed development projects, including transportation projects.

### Goal 13. Develop environmental review procedures for all development on the Colony.

Action 13.1: Prepare land use regulations which include environmental review for all new development and redevelopment on the Colony, consistent with the Helping Expedite and Advance Responsible Tribal Home Ownership Act of 2012 (HEARTH).  
 Action 13.2: Rescind the Environmental Ordinance (Ordinance 50).


### DEE DEE RAMIREZ

I am honored to serve as an Urban Indian Representative on the Executive Health Board and have served in this capacity for several terms. I have witnessed numerous challenges and changes at the Reno-Sparks Tribal Health Center. The population of Urban Natives provided services is constantly growing. The community's health and well-being is an important issue for me as an urban member.

During my tenure on the board a milestone achievement was made possible as the RSTHC Director Ms. Wilson advocated for a Medicaid State Plan Amendment. This increased our ability to offer all services under the State Medicaid Plan and increased our allowable billing encounters from three (3) up to five (5) allowable encounters per day, resulting in sustainable revenue to reinvest in the health care needs for not only the RSTHC, but for all Nevada Tribes.

I have been able to view other Tribal Clinics/Hospitals while attending conferences. The services I saw provided included several Dialysis Centers, Women's Center, ER/Trauma Center and more. These are services that can be implemented to provide a stronger and healthier community.

The RSTHC was honored to receive a visit from the U.S. Department of Health and Human Services Secretary Xavier Becerra. He toured the facilities and participated in a closed round table discussion with Tribal leaders and healthcare advocates. Out of all the tribal health centers in the country RSTHC was selected for an on-site visit.

The RSIC Language & Culture Program hosted a Pine nut soup event in Hungry Valley at the RSIC Hungry Valley education building. Many RSIC community members and surrounding tribal community members participated in a hands on pine nut soup demonstration with instructor Grace Cluette-Dick. Grace was raised on a traditional diet of indigenous foods that her family would harvest within the Coleville, Ca area. They would gather within the seasons and prepare traditional foods with great care and respect. Our instructor was honored to teach, as it was a great pine nut harvesting season.



Grace's traditional ecological knowledge (TEK) was passed down to her by her mother, Leona Cluette-Dick. Grace makes sure to pass down her TEK to the next generation. Grace also teaches Paiute Language at Spanish Springs High School. She succeeds in passing down the Paiute language and culture to our local Hungry Valley High Schoolers who attend SSHS.

Our participants got hands on experience with traditional tools. One of the first steps is cooking the pinenuts within their shells, then cracking and deshelling the pine nuts on a gridding stone. The next step is to winnow the pinenuts, separating the shell from the nut. After deshelling we cooked the pine nuts with pinion pine coals hot off the fire. The pinion pine wood is essential for flavoring and is the hottest burning wood. Participants had to continuously winnow the pine nuts and coals to prevent burning the pinenuts. Once the pine nuts were dehydrated it was time to separate the coals and clean off the pine nuts. Lastly the pine nuts were finely ground with the grinding stones. Add water and enjoy.




Pine nut soup is best served with other traditional dishes. Kenny Moore and Vickie Moore donated deer stew and pan bread, Jennie Burns made Buck berry, Choke cherry pudding and pan bread. All the participants sat down and shared a traditional meal with each other. It was very rewarding after a long day of traditional preparation.
