Washoe County Question 1
(Levy ad valorem tax for library facilities in County)

Lean Yes -In 1994, Washoe County residents approved a tax override initiative that gave the library system two cents from every \$100 in assessed property value for 30 years which is now expiring. Property taxes will stay the same regardless of the outcome of the WC-1 ballot initiative. If it fails, the two cents from every \$100 of assessed property value will no longer be redirected to the library system. Instead, that money will go into the county's general fund for general operating expenses. Proponents want sustainable and predictable funding for the library system. Opponents want more oversight over the library system by the County Commission.

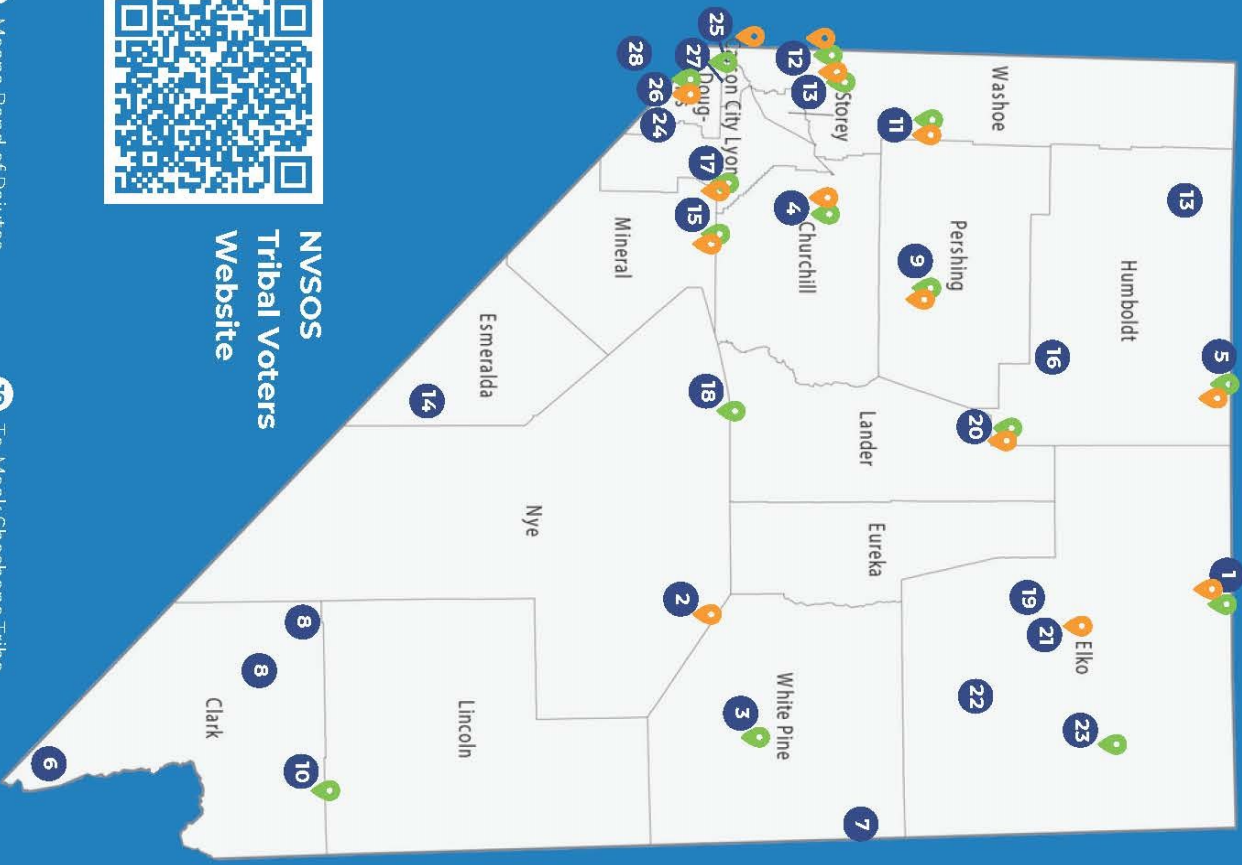

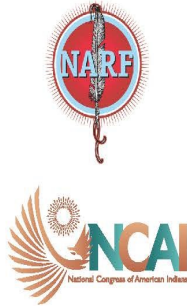

ELECTION DATES AND DEADLINES

NEVADA GENERAL ELECTION

Tuesday, November 5, 2024

Winners serve as our elected officials.



Important deadlines:

- You can register to vote in person during the early voting period from **October 19 to November 1**, or in person on Election Day, **November 5**.
- To **register by mail**, completed voter registration forms must be postmarked by **October 8**.
- To **register online**, you can do so until **November 5**.
- Nevada sends ballots to all actively registered voters between **October 16 to October 22**.
- If you want to **vote by mail**, your ballot must be postmarked by **November 5**.
- If you return your ballot in person, your ballot must be received by the County Clerk's office by 7:00 p.m. on **November 5**.
- There is same-day voter registration in Nevada, so you can register to vote and vote on Election Day, **November 5**.
- To vote early and in person, go to your County Clerk's office from **October 19 to November 1**.

MAKE YOUR VOTE COUNT!

Step 1: Are you eligible to vote?

Generally, you are eligible if you are:

- ✓ At least 18 (by Election Day)
- ✓ A citizen of the United States
- ✓ A resident of Nevada
- ✓ Live in the county where you vote for at least 30 days prior to the election
- ✓ Continuously live in your precinct for 10 days prior to the election

If you have a felony conviction, you can vote after completing your sentence.

STEP 1: REGISTER TO VOTE

You can register in person at your County Clerk's office and at any NV Department of Motor Vehicles office using the form listed below under "Register by mail," or you can:

REGISTER ONLINE:

To register online go to: <https://registertovote.nv.gov/>. Your name, Social Security Number, driver's license number, and date of birth must match information on file with the Nevada DMV. If you don't have a DMV-issued driver's license or ID, you must register by mail or in person.

REGISTER BY MAIL/PAPER FORM:

Print two copies of this form: <https://www.nvsos.gov/sosvoterreqform/>. Mail one signed application to your County Clerk and retain the other as a receipt. Your application must be postmarked by Oct. 8 or delivered in person.

SAME-DAY REGISTRATION:

Nevada allows for same-day registration. To register to vote and vote on the same day, you must have a valid Nevada driver's license, state ID card, or Tribal ID card and you must vote in-person at a polling location. Nevada voters can register to vote or update existing voter registration information in person at the polling place either during early voting or on Election Day **Tribal ID cards may also be used if they meet certain requirements**. VOTER ID REQUIREMENTS:

If you've voted in Nevada before, registered in person, or provided ID at the time of registration, you don't need to show ID to vote.

If you're voting in Nevada for the first time, registered to vote by mail or online, or didn't provide ID when you registered, be sure to bring a copy of your photo ID or a current utility bill, bank statement, government check, paycheck, or government document that shows your name and address when you vote.

Your County Clerk will notify you if you are required to provide a copy of your identification with your mail ballot. To fulfill this requirement you must submit to your County Clerk official identification of both identity and residency with your mail ballot. TRIBAL IDS:

Election board officers are required to accept a Tribal identification card as proof of identity and residency from an elector who appears in person to register to vote during early voting and on Election Day.

STEP 2: GO VOTE

VOTING IN PERSON OR BY MAIL:

You can vote in person or by absentee ballot throughout the early voting period (Oct. 19 - Nov 1). You can also return your ballot in person until 7:00 p.m. on November 5. NEVADA NATIVES VOTE

TRIBAL VOTERS WHO LIVE ON A COLONY OR RESERVATION IN NEVADA:

Nevada's Effective Absentee System for Elections (EASE) (<https://nvease.gov/>) is an online application that integrates voter registration and electronic ballot delivery and marking. EASE is available to active-duty members of the United States Armed Forces, their spouses and dependents, Nevada voters who are outside of the country, Nevada residents with a disability, and **Tribal voters who live on a colony or reservation in Nevada.**

The 2024 elections will be the first where Native voters residing on reservations or colonies in Nevada can register and vote using EASE. One of the biggest advantages of the EASE system is that it allows Tribal citizens to use their Tribal IDs to verify their identity for online voter registration. EASE will be available to use no later than Saturday, September 21, for the general election.

RESIDENTIAL ADDRESS INFORMATION:

For the purposes of preregistering or registering to vote, if you reside at a location that has not been assigned a street address (such as 123 Main Street), then you can describe the location where you live. The description must identify the location with enough specificity to allow the County Clerk to assign the location to a precinct.

VOTING WITHOUT A PERMANENT ADDRESS:

Unhoused voters or voters without a permanent address may list a shelter address, street corner, or park as their address.

RETURNING BALLOTS FOR OTHERS:

A person authorized by the voter may return the mail ballot on behalf of the voter by mail, personal delivery to the County Clerk, or delivery to any ballot drop box in the county.

ABSENTEE VOTING:

Nevada uses universal mail ballot voting. Therefore, absentee ballots will automatically be sent to all registered voters. Nevada recommends that absentee voters update their mailing address to their current

KNOW YOUR RIGHTS | USE 866-OUR-VOTE TO PROTECT THE NATIVE VOTE!



ELECTION PROTECTION 866 OUR VOTE

Help the Native American Rights Fund (NARF) and Election Protection (EP) fight Native American and Alaska Native voter suppression by standing up for your rights! If something or someone is preventing you from voting, or you have a question or need assistance with any aspect of voting, call the nonpartisan Election Protection hotline at 866-OUR-VOTE (866-687-8683) and a volunteer will assist you. When you leave your number, a NARF voting rights attorney can call you back to provide further assistance. **NOTE: If you are Native, make sure to tell the operator that you are calling about a Native voting issue.**

WHEN TO CALL

YOU ARE TOLD YOU CAN'T VOTE BECAUSE YOU DON'T HAVE APPROPRIATE ID:

Sometimes election workers improperly deny voters who try to use their tribal IDs. Sometimes election workers are required to let you fill out an affidavit if you don't have an appropriate ID. Don't leave without casting a ballot until you call 866-OUR-VOTE and talk with EP or someone at NARF about your rights! **Note:** tribal IDs are not an acceptable form of ID in all states.

YOU ASK FOR A PROVISIONAL BALLOT BUT ARE REFUSED ONE:

If an election worker says you can't vote because of a problem with your registration, ID, or any other issue, ask to cast a provisional ballot. Don't leave without voting until you talk with EP or someone at NARF about your rights!

LOCAL POLICE OR OTHER PEOPLE ARE INTIMIDATING YOU OR OTHERS:

Voter intimidation is illegal. If someone is making you or members of your community feel uncomfortable or fearful casting your vote, call 866-OUR-VOTE so NARF or EP can help mobilize a response!

THE POLLING PLACE WHERE YOU GO TO VOTE IS UNEXPECTEDLY CLOSED:

Sometimes polling places are unexpectedly closed. Election officials may say the closure is due to weather or staffing or something else. You still deserve to cast a ballot! Call 866-OUR-VOTE so NARF or EP can help mobilize a response!

YOU HAVE A DISABILITY OR DON'T SPEAK ENGLISH BUT CAN'T BRING A HELPER:

If you need assistance filling out your ballot, federal law says you are entitled to bring someone with you to help. People who are entitled to bring help include people with disabilities and people who don't read or speak English. If you are denied access to assistance casting your ballot, don't leave until you talk with EP or someone at NARF about your rights!

YOUR JURISDICTION DOESN'T PROVIDE REQUIRED LANGUAGE ASSISTANCE:

In AK, AZ, MI, WI, ID, NV, and TX, certain jurisdictions are required to make elections accessible in one of several Native languages. This means that election information must be translated into the covered Native language and that there should be bilingual election workers available to help Native language speakers understand the ballot and navigate the voting process. Covered languages include: Alabama-Coushatta, Aleut, Apache, Choctaw, Ho-Chunk, Hopi, Iñupiaq, Keres, Kickapoo, Navajo, Nez Perce, Paiute, Seminole, Shoshone, Tewa, Tiwa, and Towa, Ute, Yup'ik, Zuni. EVEN IF YOU AREN'T SURE YOUR RIGHTS HAVE BEEN VIOLATED, YOU CAN CALL 866-OUR-VOTE TO ASK ABOUT YOUR RIGHTS AND MAKE SURE TO TELL THE OPERATOR THAT YOU ARE CALLING ABOUT A NATIVE VOTING ISSUE!

REPORTING VOTER INTIMIDATION



No one should feel unsafe when exercising their right to vote.

Voter intimidation is not common and is prohibited under federal and state law. Knowing your rights and having a voting plan can help combat any attempt at voter intimidation.

If you suspect or witness voter intimidation, contact vote@narf.org and **866-OUR-VOTE**.

Voter intimidation is illegal

Multiple federal statutes prohibit voter intimidation. Under federal law, it is a crime to intimidate, threaten, or coerce a person, or attempt to do so, for the purpose of interfering with their right to vote or vote as they may choose.

State laws also provide additional protection against voter intimidation.

What is voter intimidation?

Voter intimidation takes many forms. It may be subtle or context-specific, making it more difficult to identify. It also does not have to occur within a certain distance of a polling place to be illegal. Examples of voter intimidation include:

- Spreading false or misleading information intended to disenfranchise voters
- Confronting or questioning a voter in a harassing or intimidating manner
- Aggressively questioning voters about qualifications to vote
- Violent behavior
- Verbal threats of violence
- Following voters around or invading their physical space
- Brandishing or displaying firearms
- Confronting voters in military-style or official-looking uniforms
- Law enforcement officers, including off-duty officers, loitering around voters and polling places
- Disrupting voting lines or blocking the entrance to a polling place

WHAT TO DO IF YOU SEE OR EXPERIENCE VOTER INTIMIDATION

Prior to Voting

- Make a voting plan
- If you hear about a possible threat, contact the Native American Rights Fund at vote@narf.org and call election protection at 866-OUR-VOTE
- Do not share or amplify threats on social media, as this may deter people from voting

While Voting

- If it's an emergency situation, where you or anyone else is in immediate danger, call 9-1-1 first. As soon as possible immediately inform an election official
- Document what you experienced, including what happened, who was involved, where, and when, and if any voters were discouraged or prevented from voting. Try to obtain the contact information for any voter discouraged or prevented from voting.
- Call Election Protection at 866-OUR-VOTE (866-687-8683) and contact the Native American Rights Fund at vote@narf.org
- Avoid spreading stories about intimidation efforts. Sharing incidents on social media may further deter people from voting

How to discredit disinformation efforts to intimidate or suppress voters

Online voter disinformation and intimidation efforts are at an all time high in the 2020 Election.

Here's what you can do to correct disinformation online:

- Discredit the falsehood by naming it and the motivations behind the disinformation
- State the falsehood you intend to correct
- Deliver factual information to combat the falsehood and direct people to trusted sources

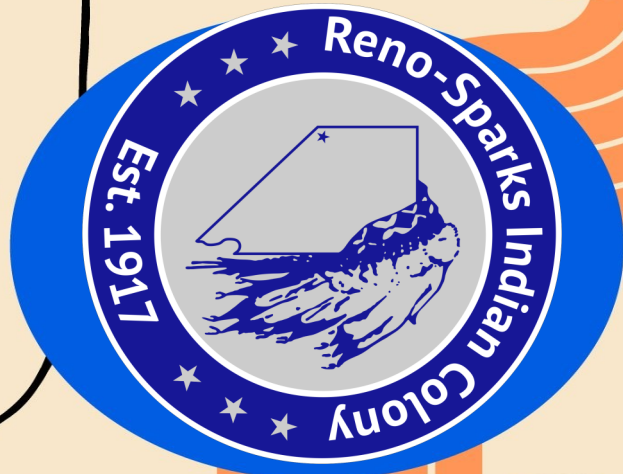
